### FY 2025 Budget Request At A Glance

### Mission:

The Civil Rights Division (CRT) protects the civil and constitutional rights of all people in this country, enforcing the Constitution and federal laws of the United States in pursuit of our founding ideals – human dignity, equal justice, and equal opportunity for all. Toward that end, the Division focuses on four primary goals:

- Creating equal opportunity to earn a living, to learn, to live where one chooses, to access credit and capital, to access basic services, and to worship freely in one's community;
- Advancing criminal justice to ensure that all individuals are treated equally under the law;
- Supporting our democracy by protecting the fundamental right to vote, helping our servicemembers, increasing language access, and preventing discrimination in federally funded and conducted activities; and
- Addressing emerging civil rights issues to match a changing legal, commercial, technological, and social landscape.

### Resources:

The FY 2025 budget request for the CRT totals \$201.3 million, which is a 6.0 percent increase over the FY 2024 Continuing Resolution.



### Organization:

The CRT is headed by the Assistant Attorney General (AAG) for Civil Rights, who is appointed by the President and confirmed by the Senate. The AAG is assisted by five Deputy Assistant Attorneys General, including a Principal Deputy Assistant Attorney General. The AAG oversees a Division that is organized into ten sections dedicated to the enforcement of the nation's civil rights laws. The Division is headquartered in Washington, DC. Due to its broad jurisdiction, Division staff travel throughout the United States to investigate, prosecute, and litigate cases and to engage in technical assistance, outreach, and training.

### Personnel:

The CRT's direct authorized positions for FY 2025 total 750 positions, including an increase of 16 positions over the FY 2024 Continuing Resolution level of 734 direct authorized positions.



### FY 2025 Strategy:

In FY 2025, the CRT will continue to pursue longstanding enforcement areas. These include ensuring effective and democratically accountable policing, protecting the rights of people with disabilities, promoting fair lending and fair housing, protecting U.S. citizens and other work-authorized individuals from employment discrimination, upholding the rights of servicemembers and veterans, and combatting hate and bias incidents.

The CRT has a wide range of activities and strategies to protect, defend, and advance civil rights in our nation:

- In the area of civil enforcement, the Division will continue to investigate and bring civil lawsuits against entities that violate anti-discrimination laws including those who commit sexual harassment against vulnerable populations in public housing;
- Similarly, the CRT will use its authority to continue investigating and prosecuting criminal cases involving interference with liberties and deprivation of rights defined in Federal law including human trafficking and forced labor;
- The Division will continue working to achieve compliance with statutes that outlaw discrimination such as providing technical assistance to encourage voluntary compliance with protections for those with disabilities under the Americans with Disabilities Act;
- The CRT will utilize outreach efforts such as providing legal resources and community engagement to achieve its mission, including, for example, protecting the religious freedom of people across this country;
- And finally, the Division will continue to actively coordinate with other DOJ components as well as Federal agencies to provide policy review, training, and collaboration on civil rights work including, for example, the protection of veterans and servicemember rights.

### FY 2025 Program Changes:

Combatting Hate and Bias Incidents: \$2.6 million and 16 positions (10 attorneys).

The CRT is dedicated to combating hate crimes and incidents, which continue to pose challenges to civil rights enforcement across the Nation. The most impacted communities include those based on race, ethnicity, and religion, as well as the disabled, transgender, and gender non-conforming communities. The CRT has effective tactics, experience, and tools available to enforce many of the 30 Federal civil rights statutes which addresses racial, ethnic, religious, and gender-based animus. statutes cover areas including education, employment, housing, policing, and public accommodations. The CRT possesses the authority to initiate criminal and civil actions. The increased funding will not only support those efforts but will enable the CRT to extend outreach to impacted communities, and provide technical assistance to Federal, State, and local law enforcement entities. It will also facilitate coordination with Federal, State, and local government agencies to share information and align enforcement strategies. Current services for this request are \$12.8 million and 97 positions (61 attorneys).
