Mission:

The mission of the Federal Bureau of Prisons (BOP) is to protect society by confining offenders in the controlled environments of prisons and community-based facilities that are safe, humane, cost-efficient, appropriately secure, and that provide work and other self-improvement opportunities to assist offenders in becoming law-abiding citizens.

Resources:


The FY 2023 budget request for BOP totals \$8,177.1 million, which is a 4.2 percent increase over the FY 2022 President's Budget and a 1.0 percent increase over the FY 2022 Enacted.


Organization:

The BOP is led by a Director, a career public administrator appointed by the Attorney General. The BOP is managed from its Central Office located in Washington, DC. The Director, Deputy Director, Assistant Directors, and General Counsel provide administrative oversight to the BOP offices and facilities. There are 122 prisons operating across the country.

Personnel:

The BOP's requested direct authorized positions for FY 2023 total 38,943 positions which is the same as the FY 2022 President's Budget.





FY 2023 Strategy:

As of February 17, 2022, the BOP was responsible for the custody and care of 153,053 Federal inmates, which includes sentenced inmates as well as detained persons awaiting trial or sentencing. The BOP maintains institution security through a combination of sound correctional practices, highly trained staff, technology, and careful classification of inmates.

The BOP fully supports the Department's law enforcement efforts to promote public safety in our communities by ensuring Federal inmates serve their sentences in facilities that are safe, humane, cost-efficient, and appropriately secure. Consistent with Executive Order 14006, the BOP expects to vacate the remaining four secure privately managed facilities, or private prisons it currently occupies by the end of calendar year 2022.

The Salaries and Expenses (S&E) appropriation funds the costs associated with administering and operating the Federal Prison System. The FY 2023 S&E budget will support the inmate population and assist in maintaining the safety of Federal prisons for staff and inmates. Current services also includes base funding of \$409.5 million for programs related to the implementation and continuation of First Step Act (FSA) initiatives, of which \$100.0 million will be provided to the Department of Labor for a workforce development initiative. The FY 2023 budget also requests a transfer of \$8.2 million of the BOP's FSA funding to the National Institute of Justice for use in performing evaluations of FSA programs and activities. To further support conditions of rehabilitative programming, improve confinement, and address augmentation in BOP facilities, the Budget proposes \$151 million to hire additional staff, including funding for 590 programmatic staff dedicated to FSA and funding for 714 front-line correctional officers.

The Buildings and Facilities (B&F) appropriation supports the site selection, design, and construction of new correctional facilities, as well as the renovation, repair, and maintenance of existing institutions.

FY 2023 Program Changes:

Salaries and Expenses

Security Camera Systems Upgrade: \$15.6 million and 0 positions.

This request will allow the BOP to begin the upgrade of security camera systems throughout BOP institutions, enhance institution safety and security by eliminating "blind spots" and improving video quality, provide for wide-range area coverage and clear picture image for enhanced internal security, criminal prosecutions and public safety. There are no current services for this request.

McGirt Resources: \$33.1 million and 0 positions.

This request will allow the BOP to improve its readiness for potential needs associated with the Supreme Court's recent *McGirt v Oklahoma* decision. There are no current services for this request.

Buildings and Facilities:

No program increases included in this request.

Rescission - BOP B&F: -\$886.5 million and 0 positions. The request proposes a cancellation of \$867.5 million prior year unobligated New Construction balances and \$19.0 million prior year unobligated Modernization and Repair balances.
