How To Help the Migration Crisis — and Make International Law

October 24, 2017

The global migration crisis has become a political crisis. As migrants continue the perilous sea journey [across the Mediterranean](#), EU politicians remain deadlocked on creating new, harmonized regulations for migration. Meanwhile, right-wing parties have gained strength across Europe, riding a wave of anti-immigrant backlash. The United States, historically the world's largest refugee resettlement country, has slashed resettlement quotas and announced [bans on refugee admissions and even travel](#) from some of the most war-torn countries on Earth.

Against this backdrop, the UN persists in building two global agreements to assist migrants and refugees. The proposed [Global Compact on Migration](#) (GCM) and [Global Compact on Refugees](#) stem from the September 2016 UN Summit on Refugees and Migrants. At the Summit, the UN General Assembly adopted the [New York Declaration for Refugees and Migrants](#), which set into motion the process to create both agreements by 2018. Based on [my academic work on refugees and migration](#), I have had the privilege of visiting the UN six times to work on the outcome documents for the Summit and participate in the process to create the GCM. Despite the hostile global political climate in which these agreements are being developed, they are not doomed to fail. Generating political will is the key to the success of the Global Compacts and to their ability to become entrenched as international law in the long term.

To understand how to make the Global Compacts work, we first must understand why they are necessary. The

creation of two Global Compacts reinforces an important legal distinction between refugees and migrants and highlights a critical gap in international law. The [1951 Refugee Convention](#) defines a refugee as a person who crosses an international border due to a well-founded fear of persecution, on the basis of race, religion, nationality, membership in a particular social group, or political opinion. [As I have documented](#), this definition was designed to protect only a very narrow group of people. Like the other foundational documents of international human rights law, the 1951 Convention was born from the ashes of World War II to prevent Nazi atrocities from happening again. It deliberately sought to protect categories of people that the Nazis had slaughtered. [On any given week](#), we need only look at the headlines to see that persecution on the basis of the five categories in the 1951 Convention remains as rampant as ever. A global commitment to protect minority rights is [as crucial now as it was on the day the 1951 Convention was signed](#).

The 1951 Convention has been joined by 145 of the UN's 193 member-states and has provided crucial protections for millions. However, it does not protect the majority of the world's displaced people. According to the UN Refugee Agency, of 65.6 million "[forcibly displaced people](#)" as of 2016, only 22.5 million qualify as refugees. The other 43.1 million have few protections under international law. Most international human rights law treaties require states to protect the rights of their own citizens, not aliens. The [Convention Against Torture](#) protects all people from being sent back to a place where they will be tortured or face other inhumane treatment, but most countries place a high burden of proof on the individual claiming the Convention's protection. The [Migrant Workers Convention](#) pertains only to workers who have contracts with employers abroad, and has only 51 state-parties. The term "migrant" itself is undefined in international law. While some regional agreements and [UN Guiding Principles](#) aim to help internally displaced people (IDPs), no binding international legal framework exists to protect them.

The GCM aims to start where the 1951 Refugee Convention ends by covering migrants who are currently unprotected by international law. The GCM starts from the premise that states must share financial and moral responsibility for migrants, regardless of where they came from and where they flee. The document will specify new commitments by states to protect the human rights of migrants. However, by design, the GCM will not be a legal instrument. Treaty-making takes years — far too long to address the acute problem of migration today, and states are often reluctant to sign a binding legal document. Instead, the GCM aims to create a framework for "safe, orderly, and regular" migration to which states will more informally commit by adopting the document at the General Assembly.

How can the UN achieve an effective agreement without the binding force of law? My article, [Displaced: A Proposal for a New International Agreement to Protect Refugees, Migrants, and States](#), outlines what states must consider to create a successful agreement. Most critically, the GCM must address the Achilles heel of international human rights law: lack of enforcement. Since the GCM will not even have legal status, it will largely be enforced through international and domestic political processes, not in courts. States will only uphold the GCM if it is in their security and economic interests to do so. Citizens of those states must be assured that having their state live up to its GCM commitments will benefit them. Only then will citizens and voters support legislation or policies that ensure the state will uphold those commitments.

How can advocates of the GCM support it through political processes in their own states? First, data collection on migration will be critical to convince governments and their citizens that upholding the GCM is in their best interests. Reliable data is necessary to answer many questions about the impact of migration on states. For example, leaders and citizens need answers to how migration will impact unemployment, housing prices, and the healthcare system; how migration affects crime and terrorism; how migrants contribute to economic growth; and how migrant assimilation can be improved. The GCM process must mandate accurate data collection so that the Compact itself can be based on evidence about what states and migrants need.

Civil society will also be crucial to enforcing the GCM. Social science research, such as Beth Simmons's landmark book [Mobilizing for Human Rights](#), shows that civil society is critical to making international human

rights law work. International human rights law provides a locus around which civil society groups can mobilize to demand enforcement of individual rights. The GCM can be a similar rallying cry for civil society. Citizens, migrants, and international non-governmental organizations (INGOs) and non-governmental organizations (NGOs) can lobby states to uphold the GCM. Academics, lawyers, and NGOs can educate migrants about the commitments that states owe them and encourage migrants and others to work to protect their rights. When possible, they can even assist migrants to protect their rights in court. And, once again, civil society can better achieve these goals when armed with accurate facts and data, to provide states and their citizens with proof of the GCM's benefits. Through such efforts, civil society can mobilize individuals to pressure their states to uphold their international commitments.

By bringing civil society into the GCM process, the UN is setting the stage for the agreement's success. Shortly after the Summit on Refugees and Migrants, some UN member-states expressed opposition to civil society's involvement in creating the GCM. In December 2016, the UN held a "Modalities Meeting" at which I and other civil society representatives spoke about how civil society could contribute positively to the GCM process. An unprecedented fifty member-states attended the Meeting, a testament to member-states' interest in and concern with having civil society involved. Ultimately, civil society was welcomed into the process and is now actively participating. States and other stakeholders, including NGOs, INGOs, academics, and refugee, migrant, and diaspora groups, are holding meetings and dialogues about the GCM, building consensus and momentum behind the document. To ensure the GCM's success, the UN must continue to involve civil society in the Global Compact process, before and after the document is adopted.

Finally, the international community must view the GCM as the beginning of a process, not as an end in itself. No Global Compacts will fully be able to stem future crises. Desperate people will always flee desperate circumstances. Solutions that the international community creates to help them today may not be good in twenty years — or even in five years — as new conflicts erupt and new innovations occur. The GCM must allow flexibility in implementation to keep it relevant, while preserving its core commitments to protecting migrants. The GCM must mandate continuous data collection and updating to ensure that states' commitments remain evidence-based. Continuously revisiting the GCM will also help capture the momentum that brought the world to coalesce around creating it in the first place. Mandatory updating will help avoid complacency about forced population displacement.

The Global Compacts on Migration and Refugees are important not only for their potential to improve human rights and international security, but also for their potential to create international law in the long term. The Global Compacts represent a new form of international agreement. They are not international law in themselves. However, they are negotiated by states, and will be adopted by the General Assembly as something more than a mere declaration. If the Global Compacts succeed, they will shape state behavior, which will create new norms that will eventually become entrenched as international law.

Global Compacts that "work" can thereby create a new model for international lawmaking through a dynamic international political process. The end result could be a victory not only for the rights of migrants, but also for the creation of self-enforcing international human rights law.

The head of Immigration and Customs Enforcement is pushing back against the media's mischaracterization of his agency's handling of illegal children, claiming they get better medical care and food than many American kids.

Outgoing Acting ICE Director Thomas Homan rejected nationally televised reports that his agents are "separating" parents from children without cause and sticking the kids in shoddy holding centers.

"These families that are in here illegally, are in these [family residential centers], we have medical on site, we have a psychologist on site, we have education on site, and you know they have access to unlimited amount of foods," said Homan.

"How many U.S. citizen children in this country don't have unlimited access to fruits and vegetables, milk, juice, medical care, dental care?" he added at a roundtable hosted by the Center for Immigration Studies.

"There are a lot of U.S. citizen children who don't get that type of care, but we are providing that care to great taxpayer expense to these families," added Homan.

Homan's agency has been accused in the media of unfairly ripping children from their parents, a charge he rejected.

He explained that once families arrive at the border, Customs and Border Patrol decides if the parents tried to enter illegally or if they have other criminal charges. If they do, their children are then ordered held at a Health and Human Services facility and it is ICE that does the transportation.

Homan said they get the same treatment as American families when parents are charged with a crime.

"I was a police officer in New York, that's where I started my law enforcement career. Children and parents get separated everyday across this country when a parent is charged with a criminal offense," said Homan. "It's sad to see the children crying when you take a parent out of the home. But because it's sad it doesn't mean we don't enforce the law," he said, adding that the focus should be on the alleged crimes of the parent.

"It isn't separating these children just for the sake of separating them, you are prosecuting a parent and even American citizens get separated when you prosecute a parent," said the long-time immigration official.

This policy is taking children from the love and care that parents provide and putting them at risk of trafficking, abuse, and getting lost in the immigration system. I have taken the lead in exposing the inadequate practices at these agencies, practices that led to HHS turning several unaccompanied minors over to human traffickers under the previous administration. And I've taken the lead in pushing these agencies to put reforms in place that ensure unaccompanied minor children who come without parents are not trafficked or abused and make their court dates.

"The administration should change course immediately and use its executive authority to keep families together and expedite their cases. If those changes aren't made, Congress should act quickly on a legislative solution to fix this problem. I'm working with my colleagues to develop a compassionate solution that upholds our immigration laws and keeps families together while their cases are being processed."

NOTE: As Chairman of the Permanent Subcommittee on Investigations (PSI), [Portman](#) has led oversight efforts in Congress to ensure that unaccompanied minors are protected from trafficking and abuse. In April, PSI held a [hearing](#) to examine efforts by the U.S. Department of Health and Human Services (HHS) and the U.S. Department of Homeland Security (DHS) to protect unaccompanied minors from human trafficking and other forms of abuse. At this hearing, HHS [testified](#) that they had lost track of more than 1,500 unaccompanied minors in a three month period. This hearing followed up on [PSI's hearing on January 28, 2016](#) at which the Subcommittee released a [report](#) detailing how HHS placed eight children with human traffickers who placed the children in forced labor on an egg farm in Marion, Ohio. The Subcommittee found that HHS had failed to establish procedures to protect UACs, such as conducting sufficient background checks on sponsors and following up with sponsors and unaccompanied minors to ensure the children's welfare.

FYI on some UAC stats we recently pulled (stats are as May 21):

--Since the beginning of FY 2015 (10/1/14), an average of 542 UAC per month have not appeared at their hearings.

--Since the beginning of FY 2015, 27,357 UAC have been issued removal orders (that includes 23,571 who were ordered removed in absentia because they didn't show up).

During that same time, 22,920 UAC were either granted relief by an IJ, granted voluntary departure, or had their cases terminated.

In short, since the surge in summer 2014 began, more UAC have been ordered removed that have been granted any type of relief. That also holds true historically, as 53% of all completed UAC cases since FY 2008 have ended with a removal order.

KEEP IN MIND: There are close to 80,000 UAC cases pending, so those numbers are subject to change.

(CNN) — A federal judge on Monday ordered the US government to temporarily pause deportations of reunited families to allow attorneys time to debate whether he should more permanently extend that order.

San Diego-based US District Court Judge Dana Sabraw addressed the issue at the top of a status hearing in a continuing family separations case filed by the American Civil Liberties Union.

Sabraw ordered the pause to allow for a full written argument on the ACLU's request to pause deportations of parents for a week after reunification.

The ACLU argued that the week would be necessary for parents to have time to fully consider the decision whether to have their children deported along with them.

decision whether to have their children deported along with them.

The ACLU's filing was made earlier Monday morning, and Sabraw gave the Department of Justice a week to respond.

But in the meantime, he ordered a "stay" of deportations until that issue can be litigated.

Lawyers for the ACLU said their motion was due to "the persistent and increasing rumors – which Defendants have refused to deny – that mass deportations may be carried out imminently and immediately upon reunification." They argue this issue is "directly related to effectuating the Court's ruling that parents make an informed, non-coerced decision if they are going to leave their children behind."

"A one-week stay is a reasonable and appropriate remedy to ensure that the unimaginable trauma these families have suffered does not turn even worse because parents made an uninformed decision about the fate of their child," the ACLU's lawyers added.



MICHIGAN MAN CHARGED WITH PROVIDING MATERIAL SUPPORT TO ISIS

WASHINGTON – In a criminal indictment unsealed in the Eastern District of Michigan today, Ibraheem Izzy Musaibli, 28, of Dearborn, Michigan, was charged with providing and attempting to provide material support to the Islamic State of Iraq and al-Sham (ISIS), a designated foreign terrorist organization.

The indictment was announced by Assistant Attorney General for National Security John C. Demers, U.S. Attorney Matthew J. Schneider of the Eastern District of Michigan and Timothy R. Slater, Special Agent in Charge of the Detroit, Michigan office of the Federal Bureau of Investigation.

Musaibli, a natural-born U.S. citizen, was detained overseas by Syrian Democratic Forces (SDF) and recently transferred into U.S. custody. Musaibli will be arraigned on the indictment at the federal courthouse in Detroit on Wednesday, July 25, 2018, at 1:00 p.m. EDT.

The indictment alleges that from about April 2015 through June 2018, Musaibli knowingly provided and attempted to provide material support to ISIS, in the form of personnel and services, knowing that ISIS is a terrorist organization and that ISIS engages in terrorism.

“The National Security Division will not tolerate threats to our country from terrorist organizations like ISIS—not least of all those that come from our own citizens,” said Assistant Attorney General Demers. “Musaibli’s alleged provision of material support to ISIS put the United States at risk and may have endangered the lives of countless innocent people. I am confident that he will face justice for his crimes, and I hope that his case sends a clear message that we will hold our citizens accountable who are apprehended overseas and tried to join a terrorist organization such as ISIS. I am also grateful to our law enforcement and military partners who made this prosecution possible.”

“The indictment alleges that, for a substantial period of time, defendant Musaibli provided material support to ISIS — one of the most violent terrorist organizations in the world. During that same time, American-backed coalition forces were fighting ISIS in Iraq and Syria,” United States Attorney Matthew Schneider stated. “We will vigorously prosecute anyone who provides, or even attempts to provide, support to terrorists.”

“The indictment in this case serves as a reminder of the danger posed by those who travel overseas to join forces with ISIS,” said Timothy R. Slater, Special Agent in Charge, Detroit Division of the FBI. “The FBI is determined to find these individuals and bring them to justice. Bringing charges in these cases will remind others what can happen if they provide assistance to foreign terrorist organizations.”

An indictment is merely a formal charge that a defendant has committed a violation of criminal law and is not evidence of guilt. Every defendant is presumed innocent unless and until proven guilty.

This case is being investigated by the FBI’s Joint Terrorism Task Force. The case is being prosecuted by Assistant U.S. Attorneys Cathleen Corken and Kevin Mulcahy of the Eastern District of Michigan with assistance from the National

Security Division's Counterterrorism Section.

The report provides data on departures and overstays, by country, for foreign visitors to the United States who entered as nonimmigrants through an air or sea Port of Entry (POE) and were expected to depart in FY 2017. The in-scope population for this report includes temporary workers and families, students, exchange visitors, temporary visitors for pleasure, temporary visitors for business, and other nonimmigrant classes of admission.

DHS has determined that there were 52,656,022 in-scope nonimmigrant admissions to the United States through air or sea POEs with expected departures occurring in FY 2017; the in-scope admissions represent the vast majority of all air and sea nonimmigrant admissions. Of this number, DHS calculated a total overstay rate of 1.33 percent, or 701,900 overstay events.

The report also breaks down the overstay rates further to provide a better picture of those overstays who remain in the United States beyond their period of admission and for whom there is no identifiable evidence of a departure, an extension of period of admission, or transition to another immigration status. At the end of FY 2017, there were 606,926 Suspected In-Country Overstays. The overall Suspected In-Country Overstay rate was 1.15 percent of the expected departures.

Overstay rate was 1.13 percent of the expected departures.

The U.S. government is using a multifaceted approach to enforce overstay violations, including improving entry and exit data collection and reporting, notifying visitors of an impending expiration of their authorized period of admission, cancelling travel authorizations and visas for violators, recurrent vetting of many nonimmigrants, and apprehending overstays present in the United States.

Visa Waiver Program (VWP) Country Overstay Rate

This report separates Visa Waiver Program (VWP) country overstay figures from non-VWP country figures. For VWP countries, the FY 2017 Suspected In-Country Overstay rate was 0.51 percent of the 22,472,710 expected departures.

Non-Visa Waiver Program Participant Overstay Rate

For non-VWP countries, the FY 2017 Suspected In-Country Overstay rate is 1.91 percent of the 14,659,249 expected departures.

Student or Exchange Visitor Visa Overstay Rate

For nonimmigrants who entered on a student or exchange visitor visa (F, M, or J visa), DHS has determined there were 1,662,369 students and exchange visitors scheduled to complete their program in the United States. However, 4.15 percent stayed beyond the authorized window for departure at the end of their program.

Canada and Mexico Overstay Rates

Unlike other countries, a majority of travelers from Canada and Mexico enter the United States by land. Figures pertaining to Canada and Mexico are presented separately from the other countries due to the fact that air and sea information represent a much smaller portion of the Canadian and Mexican travel population. For Canada, the FY 2017 Suspected In-Country Overstay rate for those traveling through air and sea POEs is 1.01 percent of 9,215,158 expected departures. For Mexico, the FY 2017 Suspected In-Country Overstay rate for those traveling through air and sea POEs is 1.63 percent of 2,916,430 expected departures. This represents only travel through air and sea POEs and does not include data on land border crossings. DHS is currently working to improve its monitoring capability for land POEs.

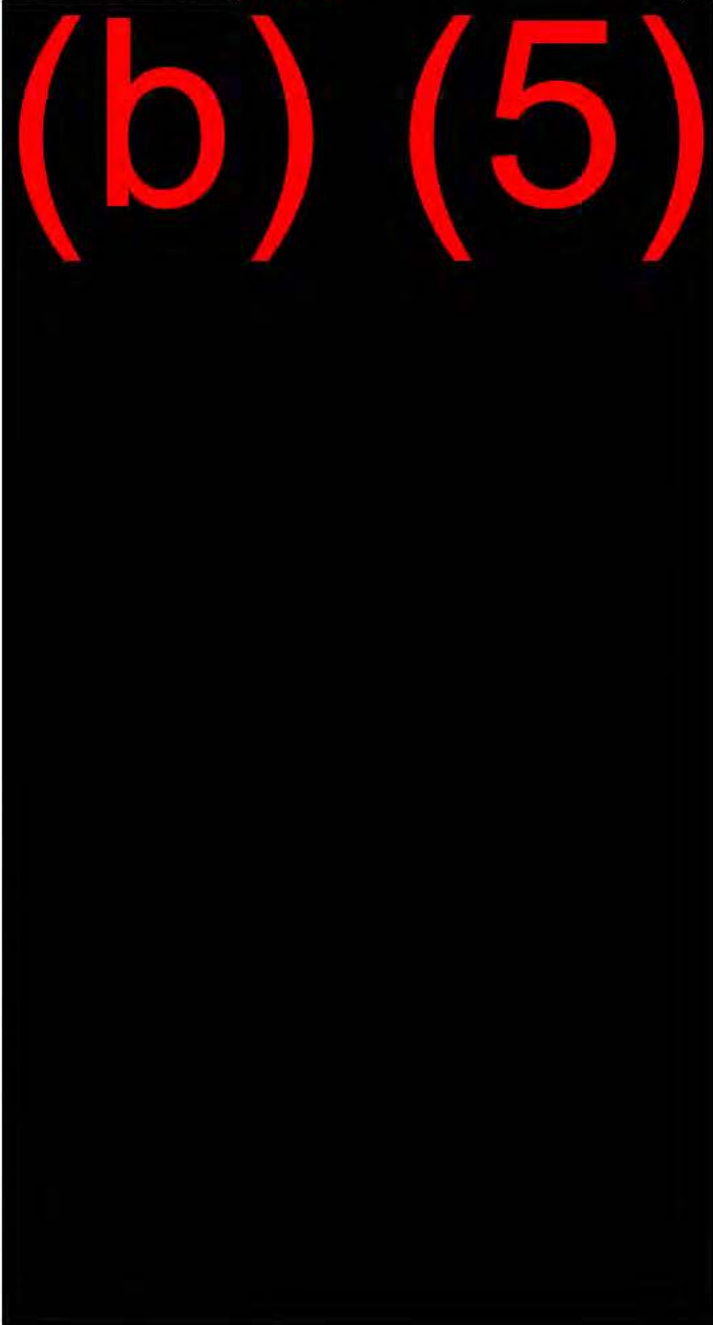
