8	The Committee met, pursuant to notice, at 9:30 a.m., in
9	Room SR-325, Russell Senate Office Building, Hon. Chuck
10	Grassley, Chairman of the Committee, presiding.
11	Present: Senators Grassley, Hatch, Graham, Cornyn,
12	Lee, Cruz, Flake, Feinstein, Leahy, Durbin, Whitehouse,
13	Klobuchar, Franken, Coons, Blumenthal, and Hirono.
14	Chairman Grassley. Before we actually start the
15	hearing, I am going to give a point of personal privilege to
16	former Chairman and my friend, Senator Leahy, to speak for a
17	few seconds that he asked to do, and I think it is very
18	appropriate that you do what you said you were going to do.

- 1 rather than--and I have not reached--gone that far, to give
- 2 you an opinion today.
- 3 Senator Graham. Immigration. You have said that the
- 4 executive order of President Obama you believe is
- 5 unconstitutional, the DACA law. Do you still have that
- 6 position?
- 7 Senator Sessions. I did, for a number of reasons.
- 8 Senator Graham. But I am not -- I mean, I agree with
- 9 you.
- 10 Senator Sessions. Right.
- 11 Senator Graham. Now we have got 800,000 people have
- 12 come out of the shadows, that have been signed up. Will you
- 13 advise the next president, President Trump, to repeal that
- 14 executive order?
- 15 Senator Sessions. That will be a decision that needs
- 16 to be studied and that he would need to agree to. But it is
- 17 an executive order -- really, a memorandum of the Department
- 18 of Homeland Security.
- 19 It would certainly be constitutional, I believe, to end
- 20 that order, and our Department of Justice, I think, could
- 21 have no objection to a decision to abandon that order.
- 22 Because it is very questionable, in my opinion,
- 23 constitutionally.

- 1 Senator Graham. Once we repeal it -- and I agree that
- 2 I believe it is an overreach -- what do we do with the
- 3 800,000 kids who have come out of the shadows?
- 4 Senator Sessions. Senator Graham, fundamentally we
- 5 need to fix this immigration system. Colleagues, it is not
- 6 been working right. We have entered more and more millions
- 7 of people illegally into the country. Each one of them
- 8 produces some sort of humanitarian concern, but it is
- 9 particularly true for children.
- 10 So we have been placed in a bad situation. I really
- 11 would urge us all to work together. I would try to be
- 12 supportive to end the illegality and put us in a position
- 13 where we can wrestle with how to handle these difficult,
- 14 compassionate decisions.
- 15 Senator Graham. Right. And the best way to do it is
- 16 for Congress and the administration to work together and
- 17 pass a law, not an executive order.
- 18 Senator Sessions. Exactly.
- 19 Senator Graham. OK. When it comes to the law of war,
- 20 do you believe that people who join al-Qaeda
- Or affiliated groups are subject to being captured or
- 22 killed under the law of war?
- 23 Senator Sessions. I do, Senator. I just do not see
- 24 how we could see it otherwise. And it is the responsibility

- So in fairness, tell me why you still oppose
- 2 that.
- 3 Senator Sessions. Well, first, I will tell you
- 4 with absolute certainty that if -- it is a decision of this
- 5 body. It is not the attorney general's decision about when
- 6 and where a mandatory minimum is imposed and whether it can
- 7 be retroactively altered.
- 8 So I will follow any law that you pass, number
- 9 one. Number two, I understood the sincere belief you had on
- 10 that issue, and it was a difficult call, and that is why we
- 11 really never worked it out.
- So I understand what you are saying, but I did
- 13 believe that you are upsetting finality in the justice
- 14 system, that you are suggesting that these kind of factors
- 15 were not considered when the plea bargaining went down. So
- 16 it is an honorable debate to have, and I respect your
- 17 position on it.
- 18 Senator Durbin. Senator, you have been outspoken
- 19 on another issue, and I would like to address it, if I
- 20 could. I have invited here today Sergeant Oscar Vazquez, if
- 21 he would be kind enough to stand up and be recognized.
- 22 Sergeant, thank you for being here.
- 23 I will tell you his incredible story in a short
- 24 form. Brought to the United States as a child, in high
- 25 school he and three other DREAMers started a Robotics Club

- 1 and won a college-level robotics competition. They made a
- 2 movie out of this story. He graduated from Arizona State
- 3 University with an engineering degree. The Obama
- 4 administration granted him a waiver and allowed him to
- 5 become a citizen and enlist in the United States Army, where
- 6 he served in combat in Afghanistan.
- 7 Senator Sessions, since joining the Senate in
- 8 1997, you have voted against every immigration bill that
- 9 included a path to citizenship for the undocumented. You
- 10 described the DREAM Act, which I introduced 15 years ago to
- 11 spare children who are undocumented through no fault of
- 12 their own, as "a reckless proposal for mass amnesty." You
- opposed the bipartisan comprehensive immigration reform bill
- 14 which passed the Senate 4 years ago. You have objected to
- immigrants' volunteering to serve in our armed forces,
- 16 saying, "In terms of who is going most likely to be a spy:
- 17 somebody from Cullman, Alabama, or somebody from Kenya?"
- 18 When I asked what you would do to address the
- 19 almost 800,000 DREAMers, like Oscar Vazquez, who would be
- 20 subject to deportation if President Obama's Executive order
- 21 was repealed, you said, "I believe in following the law.
- 22 There is too much focus on people who are here illegally and
- 23 not enough on the law."
- 24 Senator Sessions, there is not a spot of evidence
- 25 in your public career to suggest that as Attorney General

- 1 you would use the authority of that office to resolve the
- 2 challenges of our broken immigration system in a fair and
- 3 humane manner. Tell me I am wrong.
- 4 Senator Sessions. Well, you are wrong, Senator
- 5 Durbin. I am going to follow the laws passed by Congress.
- 6 As a matter of policy, we disagreed on some of those issues.
- 7 I do believe that if you continually go through a cycle of
- 8 amnesty that you undermine the respect for the law and
- 9 encourage more illegal immigration into America. I believe
- 10 the American people spoke clearly in this election. I
- 11 believe they agreed with my basic view. And I think it is a
- 12 good view, a decent view, a solid legal view for the United
- 13 States of America that we create a lawful system of
- 14 immigration that allows people to apply to this country, and
- if they are accepted, they get in; if they are not accepted,
- 16 they do not get in. And I believe that is right and just,
- 17 and the American people are right to ask for it. We have
- 18 not delivered that for them.
- 19 Senator Durbin. Senator Graham asked this
- 20 question, and I listened to your answer when he asked you
- 21 what would happen to those 800,000 currently protected by
- 22 President Obama's Executive order known as DACA, who cannot
- 23 be deported for 2 years--it is renewable--and can work for 2
- 24 years, and you said, "Let Congress pass a comprehensive
- 25 immigration reform bill."

Τ	You opposed the only bipartisan effort that we
2	have had on the Senate floor in modern memory. And what is
3	going to happen to those 800,000 if you revoke that order
4	and they are subject to deportation tomorrow? What is going
5	to happen to them? What is the humane legal answer to that?
6	Senator Sessions. Well, the first thing I would
7	say is that my response to Senator Graham dealt with whose
8	responsibility this is. I had a responsibility as a member
9	of this body to express my view and vote as I believed was
10	correct on dealing with issues of immigration. That is not
11	the Attorney General's role. The Attorney General's role is
12	to enforce the law. And as you know, Senator Durbin, we are
13	not able financially or any other way to seek out and remove
14	everybody that is in the country illegally.
15	President Trump has indicated that criminal
16	aliens, like President Obama indicated, certainly are the
17	top group of people, and so I would think that the best
18	thing for us to doand I would urge colleagues that we
19	understand this. Let us fix this system. And then we can
20	work together after this lawlessness has been ended, and
21	then we can ask the American people and enter into a
22	dialogue about how to compassionately treat people who have
23	been here a long time.
24	Senator Durbin. That does not answer the question
25	about the 800,000 who would be left in the lurch, whose

- 1 lives would be ruined while you are waiting on Congress for
- 2 a bill that you opposed.
- 3 Senator Sessions. Well, I thought it did answer
- 4 it pretty closely, what you asked, and I understand your
- 5 concerns.
- 6 Chairman Grassley. Senator Cornyn.
- 7 Senator Cornyn. Senator Sessions, congratulations
- 8 to you and your family on this once-in-a-lifetime honor to
- 9 serve as the head of the Department of Justice.
- 10 You know, sitting here listening to the questions
- 11 and some of the comments that have been made, both by the
- 12 protesters and others, it strikes me that many people have
- 13 been surprised to learn more about your record, your
- 14 outstanding record as a prosecutor, as somebody who treated
- 15 that responsibility to uphold and enforce the law and the
- 16 Constitution without fear or favor. I think some people
- 17 here listening today have been somewhat surprised by your
- 18 record in complete context.
- Those of us who have served with you in this
- 20 Senate, some as many as 20 years, like Senator Shelby and
- 21 Senator Collins, testified to your character. But I like to
- 22 think that those of us who served with you most closely in
- 23 the Senate, particularly here on the Judiciary Committee,
- 24 know more about you than just your record and your
- 25 character. We know your heart. We know what kind of person

- 1 American juris prudence. And he says that Congress has just
- 2 fallen down on its job.
- Now, of course, there are two ways. One of them is
- 4 that it writes laws that are too broad. And I would urge
- 5 all of you to be sure that when we pass a law or you pass a
- 6 law, if I am confirmed, that that law is clear and sets
- 7 limits. When it does not set limits, then you can have the
- 8 secretary of this agency or that agency claiming they have
- 9 certain authorities and we end up with a very muddled
- 10 litigation maybe resulting from it.
- So reestablishing the proper separation of powers and
- 12 fidelity to law and to limits is an important issue. And I
- 13 think, hopefully, I think that is what you are suggesting.
- 14 Senator Sasse. Could you tell me under what
- 15 circumstances, if any, you think the Department of Justice
- 16 can fail to enforce a law?
- 17 Senator Sessions. Well, it can fail to enforce it by
- 18 setting prosecutorial policies with regard to declining to
- 19 prosecute whole chunks of cases and, in fact, eliminate a
- 20 statute. If a new tax is passed and the Department of
- 21 Justice says it cannot be collected, then the law is not
- 22 followed.
- You also have the circumstances which can redefine the
- 24 statute or alter. If we are talking about improper actions,

- 1 it could expand the meaning of the words of the statute far
- 2 beyond what Congress ever intended. And that is abuse too.
- 3 Senator Sasse. And not to interrupt you too soon, the
- 4 improper, but also, what is proper? Because this
- 5 administration has made the case regularly that they need to
- 6 exercise prosecutorial discretion because of limited
- 7 resources. And obviously, there are not infinite resources
- 8 in the world, so what are some proper instances, in your
- 9 view, when an administration might not enforce a law?
- 10 Senator Sessions. Well, critics of the immigration
- 11 enforcement, the DAPA and the DACA laws, said that the
- 12 prosecutorial discretion argument went too far. It
- 13 basically just eliminated the laws from the books.
- 14 Secondly with regard to that, the president's -- well,
- 15 the order came from Homeland Security, not from the
- 16 Department of Justice, but Homeland Security's order not
- 17 only said we are not going to enforce the law with regard to
- 18 certain large classifications of people, but those people
- 19 who had not been given legal status under the laws of the
- 20 United States were given photo I.D.s, work authorization and
- 21 Social Security numbers and the right to participate in
- 22 these government programs, that would appear to be contrary
- 23 to existing law. So that would, to me, suggest an
- 24 overreach.

- 1 Senator Blumenthal. Did you agree with the
- 2 Department of Investigation finding that it had an adverse and
- 3 disparate impact on people on the basis of race?
- 4 Senator Sessions. Oh, I have never expressed an
- 5 opinion upon it and I never studied that issue in depth. But
- 6 apparently somebody must have agreed, because it was changed.
- 7 Senator Blumenthal. Did you agree with that
- 8 conclusion?
- 9 Senator Sessions. Well, yes; I was happy that
- 10 that solution was reached, yes. Very much. You do not need
- 11 to have -- you know, we should remember those things as we
- 12 move forward, setting policy, what kind of ramifications could
- 13 it have. I do not think they had voting in their mind at all,
- 14 but it did impact voting to some degree, for sure.
- Senator Blumenthal. But you took no action at the
- 16 time? You expressed no conclusion at the time, despite what
- 17 was found to be a disparate and adverse impact on voting
- 18 rights of 250,000 members of the citizens of your state?
- 19 Senator Sessions. Well, they did not ask my
- 20 opinion before they did it, and it was purely a state matter.
- 21 And I did not actively intervene, you are correct.
- 22 Senator Blumenthal. I want to ask you about the
- 23 DACA young people, the DREAMers, who have submitted
- 24 information to the Federal government about their whereabouts,
- 25 their identities, a lot of personal details. And I know that

- 1 your response, I think to a question about it, was that
- 2 Congress must act.
- But would not it violate fundamental fairness,
- 4 whether due process or some standard of constitutional due
- 5 process, to use that information, in fact, against them.
- 6 Obviously, we are not talking about a criminal proceeding, so
- 7 there is no double jeopardy.
- 8 But I guess I am asking for your commitment, as a
- 9 prospective attorney general, your respect for the
- 10 Constitution, to make a commitment that those young people
- 11 will not be deported, that you will continue that policy that
- 12 has been initiated.
- 13 Senator Sessions. Certainly you are correct that
- 14 those -- that cohort of individuals should not be targeted and
- 15 given a priority, anything like the priorities that should be
- 16 given to criminals and people who have had other difficulties
- 17 in the United States, those who have been ordered deported and
- 18 had final orders of deportation.
- 19 So I understand what you are saying there. I
- 20 think, until I have had a chance to think it through and
- 21 examine the law and so forth, I would not opine on it myself.
- 22 Number two, importantly, this is a policy of Homeland
- 23 Security. They have got to wrestle with the priorities of
- 24 their agents, what they should spend their time with and try
- 25 to do that in the most effective way.

- 1 So General Kelly will have to think that through.
- 2 I am -- simply would be, if some matter were litigated, we
- 3 would try to be supportive of the litigating position, if
- 4 possible.
- 5 So it is really a Homeland Security question.
- 6 Senator Blumenthal. I understand that Homeland
- 7 Security may be involved, but ultimately, orders to deport are
- 8 the responsibility of the Department of Justice to enforce.
- 9 You are the nominee to be the nation's chief law
- 10 enforcement officer. And more importantly, in some sense you
- 11 are a source of the nation's conscience, legal conscience.
- 12 And so I am asking you, as a prospective United
- 13 States attorney, whether your conscience would be violated by
- 14 using information submitted in good faith, by countless young
- 15 people who have been in this country since infancy, many of
- 16 them, and who trusted the government of the United States of
- 17 America to give them the benefit of that policy articulated by
- 18 the president of the United States.
- 19 You may have disagreed with that policy, but the
- 20 submission of that information in good faith on the basis of
- 21 representations by the United States of America, it seems to
- 22 me, involve a prospective commitment on your part in
- 23 representing the United States of America.
- 24 Senator Sessions. Well, you make a good point,
- 25 and that is a valid concern. I know of no policy that would

- 1 suggest that something like that would be done, and I would
- 2 not push for it. But ultimately the decision would be made by
- 3 the Homeland Security Department. They decide their
- 4 priorities for enforcement.
- 5 And then there is a question of whether or not -- I
- 6 just would not want to be in a position to say they would
- 7 never be used, but -- and I cannot make that commitment today.
- 8 I have not thought it through as to what laws might be
- 9 implicated.
- 10 But if somebody were a terrorist or had other
- 11 criminal gang connections, could you never use that
- 12 information? I do not know. I am just not prepared to answer
- 13 that today. It may not be possible to use it.
- 14 Senator Blumenthal. Well, I am -- I recognize,
- 15 Mr. Chairman, my time is up. But I will pursue this line of
- 16 questioning again, because I feel I am midway through a number
- 17 of questions.
- 18 Thank you, Senator.
- 19 Senator Grassley. Before I call on the senator
- 20 from Hawaii, I would like to note that Pat Edington, former
- 21 vice chair of the Alabama Democratic Party, wrote to our
- 22 Committee in support of this nomination. Mr. [sic] Edington
- 23 says, quote, "I truly hope our party will not make this vote
- 24 on party lines, but instead vote on the man," end of quote.

Dear Mr. President:

We respectfully request that you use your executive authority to the greatest extent possible to protect the Deferred Action for Childhood Arrivals (DACA) program.

As you know, DACA provides temporary relief from deportation to immigrant students who arrived in the United States as children if they register with the government, pay a fee, and pass criminal and national-security background checks. These young people are known as Dreamers. They came to the United States as children and are American in every way except for their immigration status. We have already invested in them by educating them in American schools. It makes no sense to squander their talents by deporting them to countries they barely remember.

Approximately 790,000 Dreamers have come forward and received DACA, which has allowed them to contribute more fully to their country as teachers, nurses, engineers, and small business owners. According to the conservative CATO Institute, deporting DACA recipients would cost over \$60 billion and would result in a \$280 billion reduction in economic growth over the next decade. The nonpartisan Institute on Taxation and Economic Policy estimates that the 1.3 million young people enrolled in or eligible for DACA pay \$2 billion each year in state and local taxes.

Following your inauguration, we were heartened when you said the following about the Dreamers: "We're going to work something out that's going to make people happy and proud. They got brought here at a very young age, they've worked here, they've gone to school here. Some were good students. Some have wonderful jobs. And they're in never-never land because they don't know what's going to happen." The following month, on February 16, you said: "We are going to deal with DACA with heart." We greatly appreciate that you have been true to your word and have kept the DACA program in place.

However, DACA now faces a grave threat. Texas Attorney General Ken Paxton and nine other states have challenged your authority as President and threatened to sue you if you do not rescind the memorandum that established DACA and announce that your Administration will not renew or issue any new DACA permits. Ironically, these states never sued President Obama over the DACA program. If this threat is successful, it would undermine your ability to set immigration policy for your Administration and put hundreds of thousands of talented young people at risk of imminent deportation.

While we appreciate your commitment to DACA, we are concerned that some members of your Administration have taken a different position. As a United States Senator, Attorney General Jeff Sessions was the Senate's most vocal opponent of the Dreamers. While he is now a member of your cabinet, the Attorney General has refused to defend your position on DACA. On April 19, the Attorney General said the following about DACA: "We can't promise people who are here unlawfully that they're not going to be deported." In an interview that aired on April 23, you said the following about the Attorney General's comments: "The Dreamers should rest easy." However, the Attorney General contradicted you again days later when he was asked if he agreed that Dreamers should rest easy, saying, "Well, we'll see. I believe that everyone that enters the country unlawfully is subject to being deported." Remarkably, in a June 30 interview the Attorney General even welcomed the states' threat to sue you, saying, "I've got to tell you, I like it that our states and localities are holding the federal government to account, expecting us to do what is our responsibility to the state and locals, and that's to enforce the law."

We urge you to respond to this threat to your executive authority by directing the Attorney General to use all legal options to defend the DACA program and thereby allow a generation of young immigrants with great potential to continue contributing to our society and economy.

Thank you for your time and consideration. We look forward to your response.



Research on Dreamers Contradicts Public Image

Any day now, President Trump is expected to make a decision on what to do about the controversial (and illegal) Deferred Action for Childhood Arrivals (DACA) program, which was launched by President Obama five years ago to give work permits and protection from deportation to illegal aliens who arrived as children and had lived here for five years — the so-called "Dreamers". Your guess is as good as mine on what he will do, but the reality is that only Congress can give authentic and permanent legal status to the Dreamers. Before they do, they should take the time to find out more about the characteristics of this population. As it turns out, the actual educational attainment and economic contributions of this group of illegal aliens does not quite match up with the public image that has been cultivated by amnesty activists and their supporters.

The federal government has disclosed very little about the <u>DACA beneficiaries</u> except for their countries of citizenship, states of residence, age, sex, and marital status (even though it <u>collects much more information</u>, including mode of entry, education, criminal history and English proficiency).

I have found only one source of credible, useful information for policymakers about the DACA population. It is an ongoing project of Harvard University researcher Roberto G. Gonzales, called the National UnDACAmented Research Project. There are important (self-acknowledged) caveats to the findings: The research is based on an online survey of just over 2,000 self-described DACA-eligible respondents and about 200 follow-up interviews. Gonzales believes that for a variety of reasons, the respondents are more educated and well-off than the DACA population as a whole.

Nevertheless, the findings are interesting. Here is a sample:

- 73 percent of DACA recipients he surveyed live in a low-income household (defined as qualifying for free lunch in high school);
- 22 percent have earned a degree from a four-year college or university;
- 21 percent have dropped out of high school;
- 20 percent have no education beyond high school and no plans to attend college;
- 59 percent obtained a new job with a DACA work permit, but only 45 percent increased their overall earnings;
- 36 percent have a parent who holds a bachelor's degree; and
- 51 percent were already employed before DACA.

None of this is to suggest that these individuals should not be considered for an amnesty or legalization program, but to suggest that the arguments in favor of such a program are largely political rather than economic. Immigrants who are not highly educated and who are working in low-paying jobs are more likely to access welfare and other public assistance programs over the course of their lives. If Congress decides to enact an amnesty program, which I think is likely, then it would make sense from a fiscal standpoint to cut other forms of legal immigration, such as the chain migration categories, that also tend to strain our public coffers.

Raise More than a Quarter Trillion Dollars of Tax

Revenue by Ending Tax Subsidies for Unauthorized Employment of Illegal Aliens

Aliens enter the United States without authorization for many reasons, but for most of them the goal is to secure employment at much higher wages than are available in their native countries. While breaking the law provides very significant economic benefits to these illegal workers and to the businesses that hire them, it comes at a cost to American workers. According to Harvard economist George Borjas, recent empirical research indicates that American workers suffer a reduction of \$99 billion to \$118 billion in annual wages because of illegal immigration.¹

The economic rewards of unauthorized employment of aliens are not limited to the higher wages of the illegal workers and the lower labor costs of their employers. Unauthorized alien workers and their employers also enjoy multi-billion dollar tax deductions and tax credits that were enacted into law for the benefit of law-abiding workers and businesses.

When Congress returns from summer recess on September 5, it is expected to focus attention on a major reform of the federal income tax system, including a combination of lower rates and other tax incentives to families and to businesses. The largest challenge facing tax reformers is finding sufficient additional revenue to pay for the tax cuts and tax incentives they promised to the people who elected them. In fairness to the American families and businesses to whom these tax cuts have been promised, and in particular to the American families whose household incomes have been diminished by illegal immigration, Congress should consider eliminating unwarranted tax breaks to unauthorized alien workers and their employers.

Each of the following reforms — one that eliminates a tax subsidy for employers of unauthorized aliens and the other that eliminates a tax subsidy for the unauthorized workers — comes with an estimate of the additional revenues that would be raised by the reform. Together they could raise \$296 billion over 10 years — more than a quarter-trillion dollars.

1. No Deduction for Wages Paid to Illegal Aliens. Section 162(e) of the Internal Revenue Code denies a deduction for "illegal payments". Even though it is illegal to employ unauthorized alien workers, the IRS has ruled that section 162(e) does not apply to the wages paid to those aliens, even if the employer knowingly broke the law.² On January 3, 2017, Rep. Steve King and eight other members of Congress introduced H.R. 176, the New Illegal Deduction Elimination Act, Section 2 of which would amend section 162(e) to clarify that no deduction is allowed for wages paid to unauthorized alien workers. H.R. 176 provides employers a "safe harbor", allowing a deduction to employers that used the Department of Homeland Security's free, online E-Verify system to confirm the employee's eligibility to work.

The amount of wages paid to unauthorized alien workers cannot be known with certainty. One of the most extensive studies of unauthorized immigrants in the United States was conducted by the Pew Hispanic Center in 2009. According to that study, there were approximately 8.3 million undocumented immigrants in the U.S. labor force, a figure that Pew more recently estimated had fallen to 8.0 million. Pew estimated the median household income of unauthorized worker families to be approximately \$36,000 and that there were approximately 1.75 workers per household, implying median per-worker earnings of \$20,571. Multiplying Pew's estimated number of unauthorized alien workers by the earnings-per-worker estimate yields an estimated total of wages paid to unauthorized alien workers of approximately \$165 billion.

Many unauthorized workers are employed in the "underground economy", i.e., by households and other employers that are not reporting or paying payroll taxes and presumably are not deducting the wages. A 2013 report by the Social Security Administration estimated that, of approximately seven million alien workers in various irregular work statuses in 2010, approximately 3.1 million (44 percent) had Social Security numbers (mostly false or fraudulently secured), while approximately 3.9 million (56 percent) were working in the "underground economy". On the assumption that employers reported payroll taxes and claimed wage expense deductions only for the 44 percent of unauthorized workers who could produce an SSN, and that most employers deducted wages at or near the corporate tax rate of 35 percent, we estimate that disallowing a deduction for wages paid to unauthorized alien workers would increase federal

tax revenues by approximately \$25.4 billion per year (35 percent x 44 percent x \$165 billion), or \$254 billion over 10 years.

2. Deny Refundable Tax Credits to Illegal Aliens. Section 24(a) of the Internal Revenue Code allows a \$1,000 per-child tax credit for taxpayer's whose earnings fall below a specified threshold. The Child Tax Credit is refundable to the extent it exceeds the taxpayer's tax liability, in which case it is referred to as the Additional Child Tax Credit or ACTC. A 2011 report by the U.S. Treasury Inspector General for Tax Administration explained that aliens authorized to work in the United States are required to obtain a Social Security number (SSN). For aliens who need to file U.S. federal tax returns for other reasons, such as to claim refunds of withholding tax on dividends, the IRS issues Individual Tax Identification Numbers (ITINs). Unfortunately, according to the inspector general, the IRS had been permitting aliens to claim ACTCs on returns that reported an ITIN rather than a Social Security number.

The payment of ACTCs to illegal aliens is arguably a direct violation of the Personal Responsibility and Work Opportunity Act of 1996 ("PRWOA"), which expressly provides that an illegal alien "is not eligible for any Federal public benefit." The IRS has applied the PRWOA rule to prohibit payments of Earned Income Tax Credits to ITIN filers, but based on a questionable interpretation of the law has allowed ITIN filers refunds of ACTCs.⁹

According to the Inspector General, "[b]ased on claims made in Processing Year 2010, disallowance of the ACTC to filers without a valid SSN would reduce Federal outlays by approximately \$8.4 billion over 2 years," i.e., \$4.2 billion per year. Although the inspector general's figures are based on 2010 fiscal data, Treasury Department tax expenditure estimates indicate that the total child tax credit expenditure was virtually unchanged between 2010¹⁰ and 2017. Accordingly, based on the inspector general's report, we estimate that limiting the Child Tax Credit to taxpayers with Social Security numbers would increase federal tax revenues by approximately \$4.2 billion per year, or \$42 billion over 10 years.

Dear Acting Secretary Duke,

I write to advise that the Department of Homeland Security (DHS) should rescind the June 15, 2012, DHS Memorandum entitled "Exercising Prosecutorial Discretion with Respect to Individuals Who Came to the United States as Children," as well as any related memoranda or guidance. This policy, known as "Deferred Action for Childhood Arrivals" (DACA), allows certain individuals who are without lawful status in the United States to request and receive a renewable, two-year presumptive reprieve from removal, and other benefits such as work authorization and participation in the Social Security program.

DACA was effectuated by the previous administration through executive action, without proper statutory authority and no established end-date, after Congress' repeated rejection of proposed legislation that would have accomplished a similar result. Such an open-ended circumvention of immigration laws was an unconstitutional exercise of authority by the Executive Branch. The related Deferred Action for Parents of Americans and Lawful Permanent Residents (DAPA) policy was enjoined on a nationwide basis in a decision affirmed by the Fifth Circuit on the basis of multiple legal grounds and then by the Supreme Court by an equally divided vote. See Texas v. United States, 86 F. Supp. 3d 591, 669-70 (S.D. Tex.), aff'd, 809 F.3d 134, 171-86 (5th Cir. 2015), aff'd by equally divided Court, 136 S. Ct. 2271 (2016). Then-Secretary of Homeland Security John Kelly rescinded the DAPA policy in June. Because the DACA policy has the same legal and constitutional defects that the courts recognized as to DAPA, it is likely that potentially imminent litigation would yield similar results with respect to DACA.

In light of the costs and burdens that will be imposed on DHS associated with rescinding this policy, DHS should consider an orderly and efficient wind-down process.

As Attorney General of the United States, I have a duty to defend the Constitution and to faithfully execute the laws passed by Congress. Proper enforcement of our immigration laws is, as President Trump consistently said, critical to the national interest and to the restoration of the rule of law in our country. The Department of Justice stands ready to assist and to continue to support DHS in these important efforts.





ATTORNEY GENERAL SESSIONS DELIVERS REMARKS ON DACA

Washington, DC

Remarks as prepared for delivery

Good morning. I am here today to announce that the program known as DACA

that was effectuated under the Obama Administration is being rescinded.

The DACA program was implemented in 2012 and essentially provided a legal status for recipients for a renewable two-year term, work authorization and other benefits, including participation in the social security program, to 800,000 mostly-adult illegal aliens.

This policy was implemented unilaterally to great controversy and legal concern after Congress rejected legislative proposals to extend similar benefits on numerous occasions to this same group of illegal aliens.

In other words, the executive branch, through DACA, deliberately sought to achieve what the legislative branch specifically refused to authorize on multiple occasions. Such an open-ended circumvention of immigration laws was an unconstitutional exercise of authority by the Executive Branch.

The effect of this unilateral executive amnesty, among other things, contributed to a surge of unaccompanied minors on the southern border that yielded terrible humanitarian consequences. It also denied jobs to hundreds of thousands of Americans by allowing those same jobs to go to illegal aliens.

We inherited from our Founders—and have advanced—an unsurpassed legal heritage, which is the foundation of our freedom, safety, and prosperity.

As the Attorney General, it is my duty to ensure that the laws of the United States are enforced and that the Constitutional order is upheld.

No greater good can be done for the overall health and well-being of our Republic, than preserving and strengthening the impartial rule of law. Societies where the rule of law is treasured are societies that tend to flourish and succeed.

Societies where the rule of law is subject to political whims and personal biases tend to become societies afflicted by corruption, poverty, and human suffering.

To have a lawful system of immigration that serves the national interest, we cannot admit everyone who would like to come here. That is an open border policy and the American people have rightly rejected it.

Therefore, the nation must set and enforce a limit on how many immigrants we admit each year and that means all can not be accepted.

This does not mean they are bad people or that our nation disrespects or demeans them in any way. It means we are properly enforcing our laws as Congress has passed them

It is with these principles and duties in mind, and in light of imminent litigation, that we reviewed the Obama Administration's DACA policy.

Our collective wisdom is that the policy is vulnerable to the same legal and constitutional challenges that the courts recognized with respect to the DAPA program, which was enjoined on a nationwide basis in a decision affirmed by the Fifth Circuit.

The Fifth Circuit specifically concluded that DACA had not been implemented in a fashion that allowed sufficient discretion, and that DAPA was "foreclosed by Congress's careful plan."

In other words, it was inconsistent with the Constitution's separation of powers. That decision was affirmed by the Supreme Court by an equally divided vote.

If we were to keep the Obama Administration's executive amnesty policy, the likeliest outcome is that it would be enjoined just as was DAPA. The Department of Justice has advised the President and the Department of Homeland Security that DHS should begin an orderly, lawful wind down, including the cancellation of the memo that authorized this program.

Acting Secretary Duke has chosen, appropriately, to initiate a wind down process. This will enable DHS to conduct an orderly change and fulfill the desire of this administration to create a time period for Congress to act—should it so choose. We firmly believe this is the responsible path.

Simply put, if we are to further our goal of strengthening the constitutional order and the rule of law in America, the Department of Justice cannot defend this type of overreach.

George Washington University Law School Professor Jonathan Turley in testimony before the House Judiciary Committee was clear about the enormous constitutional infirmities raised by these policies.

He said: "In ordering this blanket exception, President Obama was nullifying part of a law that he simply disagreed with.....If a president can claim sweeping discretion to suspend key federal laws, the entire legislative process becomes little more than a pretense...The circumvention of the legislative process not only undermines the authority of this branch but destabilizes the tripartite system as a whole."

Ending the previous Administration's disrespect for the legislative process is an

important first step. All immigration policies should serve the interests of the people of the United States—lawful immigrant and native born alike.

Congress should carefully and thoughtfully pursue the types of reforms that are right for the American people. Our nation is comprised of good and decent people who want their government's leaders to fulfill their promises and advance an immigration policy that serves the national interest.

We are a people of compassion and we are a people of law. But there is nothing compassionate about the failure to enforce immigration laws.

Enforcing the law saves lives, protects communities and taxpayers, and prevents human suffering. Failure to enforce the laws in the past has put our nation at risk of crime, violence and even terrorism.

The compassionate thing is to end the lawlessness, enforce our laws, and, if Congress chooses to make changes to those laws, to do so through the process set forth by our Founders in a way that advances the interest of the nation.

That is what the President has promised to do and has delivered to the American people.

Under President Trump's leadership, this administration has made great progress in the last few months toward establishing a lawful and constitutional immigration system. This makes us safer and more secure.

It will further economically the lives of millions who are struggling. And it will enable our country to more effectively teach new immigrants about our system of government and assimilate them to the cultural understandings that support it.

The substantial progress in reducing illegal immigration at our border seen in recent months is almost entirely the product of the leadership of President Trump and his inspired federal immigration officers. But the problem is not solved. And without more action, we could see illegality rise again rather than be eliminated.

As a candidate, and now in office, President Trump has offered specific ideas and legislative solutions that will protect American workers, increase wages and salaries, defend our national security, ensure the public safety, and increase the general well-being of the American people.

He has worked closely with many members of Congress, including in the introduction of the RAISE Act, which would produce enormous benefits for our country. This is how our democratic process works.

There are many powerful interest groups in this country and every one of them has a constitutional right to advocate their views and represent whomever they choose.

But the Department of Justice does not represent any narrow interest or any subset of the American people. We represent all of the American people and protect the integrity of our Constitution. That is our charge.

We at Department of Justice are proud and honored to work to advance this vision for America and to do our best each day to ensure the safety and security of the American people.

Jeff Sessions announces DACA program to be rescinded

"Attorney General Jeff Sessions announced the Trump administration's intentions to officially rescind the Deferred Action for Childhood Arrivals (DACA) program, effectively ending the 2012 program that has deferred deportations for those who came to the United States as young immigrants. Sessions called the current program an 'unconstitutional' overreach of executive authority that caused great legal concern after Congress initially rejected the legislative proposals to extend similar benefits to illegal immigrants." "Attorney General Jeff Sessions said the Trump Administration has decided to rescind Deferred Action for Childhood Arrivals, or DACA, a program enacted by former President Barack Obama that has prevented nearly 800,000 immigrants from deportation since 2012. The Trump Administration decided to phase out the program following the threat of legal action by Republican attorneys general from nine states against DACA. Congress now has six months to develop a policy that decides the fate of Dreamers, or those who have benefitted from the program. In a letter to Acting Department of Homeland Security Secretary Elaine Duke on Monday, Sessions wrote that the program 'was an unconstitutional exercise of authority by the Executive Branch' that would not withstand a court challenge." Jeff Sessions' DOJ Just Secured An Islamic Group's Right To Build A Mosque

"The Department of Justice (DOJ) announced Monday it has settled a civil rights dispute with a Pennsylvania township that refused to approve the construction of a mosque for a local Muslim congregation. The settlement provides the congregation the necessary zoning approval to build the mosque, and proscribes other remedial measures. The congregation must still obtain approval from the town and various county and state regulators before construction begins. 'Federal law protects the rights of all religious communities to build places of worship free from discrimination," said John Gore, acting chief of DOJ's Civil Rights Division. 'This agreement ensures that all citizens of Bensalem Township may freely exercise this important civil right." The Department intervened in the long-running dispute in 2016. Government lawyers sued the town of Bensalem, Penn., arguing the town zoning board discriminated against an Islamic group by denying their request for a routine zoning variance in order to build a mosque on three adjoining parcels owned by the congregation. DOJ argued the

denial constituted a violation of the Religious Land Use and Institutionalized Persons Act (RLUIPA)." (The Daily Caller)

Novo Nordisk Settles U.S. Suit Over Victoza for \$58.65 Million

"Novo Nordisk A/S reached a settlement with the U.S. Justice Department to end a suit over the marketing and sale of Victoza, a diabetes treatment. The drugmaker agreed to pay \$58.65 million, including \$12.15 million for alleged violations of the Federal Food, Drug and Cosmetics Act, according to a statement by the Justice Department. The government filed the complaint in the Washington federal court earlier Tuesday. The court docket erroneously showed the U.S. demanding \$12.15 billion." (Bloomberg)

Novo Nordisk Agrees To Pay \$58 Million For Failure To Comply With FDA-Mandated Risk Program

Pharmaceutical Manufacturer Novo Nordisk Inc. will pay \$58.65 million to resolve allegations that the company failed to comply with the FDA-mandated Risk Evaluation and Mitigation Strategy (REMS) for its Type II diabetes medication Victoza, the Justice Department announced today. The resolution includes disgorgement of \$12.15 million for alleged violations of the Federal Food, Drug, and Cosmetic Act (FDCA) from 2010 to 2012 and a payment of \$46.5 million for alleged violations of the False Claims Act (FCA) from 2010 to 2014. Novo Nordisk is a subsidiary of Novo Nordisk U.S. Holdings Inc., which is a subsidiary of Novo Nordisk A/S of Denmark. Novo Nordisk's U.S. headquarters is in Plainsboro, New Jersey.

Attorney General Sessions Delivers Remarks On DACA

"Good morning. I am here today to announce that the program known as DACA that was effectuated under the Obama Administration is being rescinded. The DACA program was implemented in 2012 and essentially provided a legal status for recipients for a renewable two-year term, work authorization and other benefits, including participation in the social security program, to 800,000 mostly-adult illegal aliens. This policy was implemented unilaterally to great controversy and legal concern after Congress rejected legislative proposals to extend similar benefits on numerous occasions to this same group of illegal aliens. In other words, the executive branch, through DACA, deliberately sought to achieve what the legislative branch specifically refused to authorize on multiple occasions. Such an open-ended circumvention of immigration laws was an unconstitutional exercise of authority by the Executive Branch. The effect of this unilateral executive amnesty, among other things, contributed to a surge of unaccompanied minors on the southern border that yielded terrible humanitarian consequences. It also denied jobs to hundreds of thousands of Americans by allowing those same jobs to go to illegal aliens. As the Attorney General, it is my duty to ensure that the laws of the United States are enforced and that the Constitutional order is upheld..."

Justice Department And Bensalem Township Settle Lawsuit Over Alleged Religious Land Use And Institutionalized Persons Act Violations

The Justice Department today announced an agreement with Bensalem Township, Pennsylvania, to resolve allegations that the Township violated the Religious Land Use and Institutionalized Persons Act of 2000 (RLUIPA) when the Township denied zoning approval to allow the Bensalem Masjid to build a mosque on three adjoining parcels of land in the Township. "Federal law protects the rights of all religious communities to build places of worship free from discrimination," said Acting Assistant Attorney General John Gore, head of the Justice Department's Civil Rights Division. "This agreement ensures that all citizens of Bensalem Township may freely exercise this important civil right." The agreement resolves a lawsuit that the Department filed in July 2016. A separate agreement resolving a similar lawsuit brought by the Bensalem Masjid against Bensalem Township has also been reached.

THE PHYLLIS SCHLAFLY REPORT Ending DACA Restores the Rule of Law by John and Andy Schlafly September 5, 2017

President Trump has delivered again on a campaign promise, by ending the unlawful pandering to illegal aliens. The Deferred Action for Childhood Arrivals program, known as DACA for short, was an illegal executive order by President Obama that prevented the deportation of adults who are unlawfully in our country.

Most of the beneficiaries of DACA are not children at all, but are young, able-bodied adults who are taking jobs and other benefits away from American citizens. Many states, which are being bankrupted by the burdens placed on their budgets by these illegal aliens, were planning to bring litigation to block DACA from remaining in effect.

President Trump's plan to phase out DACA, which granted amnesty for illegal aliens who claim they were brought to our country as children, is an artful way of fulfilling two promises he made as a candidate. It restores the rule of law to part of our immigration law that had been undermined by President Obama's executive actions, while also extending appropriate compassion to the 800,000 people who signed up in good faith for temporary legal status.

No new applications will be accepted without further action by Congress, but existing applications will continue to be processed, and DACA privileges will be honored until they expire. The government will continue issuing DACA renewals for another six months, which gives Congress plenty of time to consider a permanent law.

Trump's decision to pass the responsibility to Congress, where it belongs, is the best part, contrary to the famous statement by his predecessor Harry Truman that "the buck stops here" in the Oval Office. The Constitution gives Congress the power to make our immigration policy, so any change in the law must start there.

By rolling out the new policy in this way, Trump has not revoked anyone's legal status, nor is anyone in danger of being "rounded up" for deportation. DACA recipients still have the same rights they had before, no more and no less.

DACA was never supposed to be permanent. When President Obama unilaterally instituted the program in 2012 without Congressional approval, he promised recipients temporary protection for two years at a time — and President Trump is honoring that pledge.

Remember, all DACA recipients are illegal aliens — citizens of another country who came here illegally, even if they were brought here as children. Many of them actually came here on their own as teenagers, and many of the children were "brought" by smugglers or traffickers.

Among those who preemptively denounced Trump's announcement were Apple and Microsoft, both of which said they have DACA recipients on their payrolls. The companies didn't say how much the "Dreamers" were being paid or why no U.S. citizens or legal residents could be found to do those jobs.

Annie and Microsoft hannen to be the higgest abusers of the system that allowe LLS

technology corporations to avoid federal tax on earnings parked in overseas accounts. Apple's untaxed cash hoard has reached an astounding \$246 billion, while Microsoft is in second place with \$131 billion overseas.

A group of CEOs signed a joint letter claiming that ending DACA would hurt the economy, but Treasury Secretary Steven Mnuchin is not buying it, saying, "There's a lot of people that left the workforce, and our objective is to bring them back into the workforce." Mnuchin came from the Wall Street firm of Goldman Sachs, but he obviously gets the Trump doctrine to put Americans first.

In the furor over what to do about so-called Dreamers (illegal aliens who entered the United States as children), it's important to remember that DACA was never lawfully instituted by President Obama in the first place. DACA's companion program, known as DAPA, was thrown out by the federal courts last year, and DACA was likely to suffer the same fate.

Legislation to grant legal status to Dreamers was introduced in Congress as far back as 2001 and was rejected many times since then, most recently in 2010 when Democrats controlled both Houses. In addition to defeating those stand-alone bills, public opposition killed "comprehensive immigration reform" in 2006, 2007, and 2013.

Before creating DACA in 2012, President Obama often said that he had no authority to grant legal status to Dreamers, and he also said that doing so "would be both unwise and unfair." After changing his mind in an election year, he described DACA as "a temporary stopgap measure."

House Speaker Paul Ryan and other Republicans now say they want DACA to continue, but many Democrats would go much further if they had the chance. A new Dream Act could extend legal status and provide benefits to millions of currently illegal residents, not just the 800,000 who signed up so far.

On at least 22 occasions, President Obama himself admitted that he lacked the authority as president to implement a DACA-like program. Then, under pressure from the Left, President Obama imposed one anyway.

By end that unlawful action by Obama, President Trump properly restored the role of Congress over our immigration system. Congressmen are elected every two years in the House, and if they will hear from their voters if they try to continue a program that prefers illegal aliens over American citizens.

Attorney General Jeff Sessions' assertion Tuesday that so-called Dreamers have taken jobs away from American citizens is "wrong," Sen. Lindsey Graham declared Wednesday morning, pushing back against his former Senate colleague and calling for compassion from Congress.

"Jeff Sessions is wrong. These kids are not taking jobs from American citizens, they're part of our country," Graham (R-S.C.) told NBC's "Today" show, rebuking Sessions' assertion from the previous day. "They're fully employed for the most part, they're in school, they will add great value. The president is right to want to have a heart for these kids."

The attorney general's comment about Dreamers, undocumented immigrants who were brought to the U.S. as children, came during his announcement that the Trump administration will rescind DACA, a program that offers work permits to Dreamers and protects them from deportation. Sessions, known as a hawk on immigration issues during his Senate tenure, blamed the program for hurting American job-seekers and for creating a "humanitarian crisis" on the U.S.-Mexico border.

President Donald Trump, though, has adopted a warmer attitude towards Dreamers, pledging to treat them compassionately both before and after his announcement rescinding DACA. The president's decision keeps the program in place for six months, creating a window for Congress to act on legislation to more permanently protect Dreamers. Similar legislation, dubbed the DREAM Act, failed to pass Congress during former President Barack Obama's administration.

Should Congress fail, Trump wrote on Twitter Tuesday night that he would "revisit this issue."

Graham, in his "Today" show interview, said Congress should create not just a path to legal status but also offer U.S. citizenship to Dreamers. But he also said Trump was right to rescind DACA because the program was on track to be ruled unconstitutional.

"The compassionate thing to do is to give these kids legal status, let them become citizens, they are all non-felons, they have no other country to go to," Graham said. "They came here as young children, they've lived their life in America and they would add great value to our country. That's the right thing to do regarding the kids."

The South Carolina senator predicted that legislation to protect Dreamers could make its way through Congress packaged alongside funding for border security, money that would help Trump make good on a campaign promise. But Graham also said that money for a wall along the U.S.-Mexico border, a specific campaign pledge of the president's, need not be part of an immigration compromise, in part because it would not be effective.

"I think there is a congressional deal to be made for border security, that would not include a 2,200 mile wall, and the DREAM Act," Graham said. "Because nobody — I've been to the border — nobody believes a 2,200 mile wall is the way to secure a border."




