DOJ leadership has authorized immediate departure of the DOJ workforce in the District of Columbia (except for DOJ Emergency Personnel). Please inform your non-emergency onsite staff in Washington to depart work immediately. Employees in DOJ RFK Main Bldg may depart via the 10th Street Gate.

Given the curfew, and the potential that the crowd presence in downtown DC this afternoon could impact transportation routes, leaving work as soon as possible is important. Please get this message immediately to your workforce/on-site staff.
