**RELIGIUS LIBERTY OUTREACH: Faith Based Leadership – Law Enforcement Partnerships for Urban revitalization, Violent Crime Reduction, Prevention, Awareness and Public Safety**

Pastor Troy Martinez has demonstrated leadership and worked successfully in the inner-cities to reduce homicide, gang and gun violence. Statistical and anecdotal proven results for over 25 years in both Los Angeles, Ca and Las Vegas, NV are evidence of the Faith based violence reduction strategies documented successful outcomes to increase public safety. As founder of 10,000 kids non-profit both Criminal Justice expertise and Faith provide a wide scope of solutions to social challenges.

**Pastor Martinez is the Chair of Rebuilding Every City Around Peace, Las Vegas (RECAP).** RECAP LV is part of a national community-based antiviolence group that are mobilizing cities across the United States to end the era of gang-violence, gun-violence and restore neighborhoods to peace.

The RECAP Las Vegas has an official partnership with the Las Vegas Metropolitan Police Department (LVMPD). Pastor Troy assisted in the development of the policy of the department to strengthen its partnership with the community by coordinating with faith-based leaders, community and business partners and stakeholders who can assist in bringing about sense of calm and peace to an affected community in the aftermath of a violent crime; help suppress future retaliatory violence stemming from that violent crime; and establish a collaborative effort to identify, develop and implement joint strategies to enhance and promote a culture of non-violence in our community.

As RECAP Chair Pastor Martinez oversees the recruitment and training of Certified Violence Responders with the police department. These Violence Responders are on call 24 hour a day. They are dispatched by the RECAP Chair when a violent crime fits the criteria; Primary Activation (Phase I) – A faith-based/community response initiated by the department when a preliminary investigation of a violent event indicates the strong probability of retaliation, a violent event that involves youth crews, gangs, or racial tension; an event so egregious that it affects the safety and security of the affected community, despite the fact there is little or no likelihood of retaliation; or circumstances prior to and/or after civil unrest incident(s).

The RECAP LV has expanded to all LVMPD Area Bureau Commands since 2013 (7<sup>th</sup> largest Police Department in the Nation). Pastor Martinez was a founding member of the original Pilot model then documented by the University of Las Vegas Nevada, Criminal Justice Department under

the “Safe Village Initiative” in 2007. The initiative saw a reduction of homicide by 40% and shootings 65% in targeted areas. The International Association of Chiefs of Police recognized LVMPD with the Webber Seavey Award for the Safe Village Initiative.

## Violent Crime Reduction

### Through City-Community Partnerships and Faith-Based Leadership Summary

**Program Summary:** The “Rebuilding Every City Around Peace” (RECAP) Initiative brings all members of the Las Vegas government and community together to reduce violence through formal partnerships and, most importantly, through a direct, personal touch. Under RECAP, faith leaders work directly with police, government, and community leaders to come up with strategies to reduce violence citywide. The Faith-based component is led by Pastor Troy Martinez.

**Mission:** Pilot a multifaceted partnership between faith-based organizations, law enforcement, government agencies and community to reduce overall violence and its impact. Expand the model to every Area Command throughout the Las Vegas valley. Expand a replicable RECAP model nationally.

**‘Statistics’<sup>[1]</sup>:** The initial 2007 “Safe Village” pilot, which was the forerunner to RECAP:

- Started in a West Las Vegas target area of 3 square miles with a population of 19,800
- Led to a 40% reduction in homicide in one year
- Led to a 65% reduction in violence in one year
- Led to a reduction in gun-related crimes of 363 to 205 (56% reduction) in one year

The RECAP Initiative from 2007-2017:

- Expanded to a target area of 8,061 square miles with a population of 2,027,000
- Led to a decrease of 9.06% for violent calls-for-service citywide
- Increased its coalition in partnership with the Mayor of Las Vegas’s Faith Initiative(MFI) to include more than 120 faith leaders representing over 70,000 congregants. The MFI is the 2017 US Conference of Mayors Award winning program.
- Collaborated with Metro’s Multi Cultural Advisory Council and the US Department of Justice to increase police-to-community communication and relationship-building<sup>[2]</sup>
- Led to a reduction in the number of officer-involved shootings (OIS) by 37% since 2011, with total number of fatal OIS incidents down by 67%
- Created the Nevada Sex Trafficking Awareness Campaign and airing an Emmy-nominated documentary to 187,000 households and training more than 18,000 high school students per semester on sex-trafficking awareness and prevention

After ten years of successful reduction in violent crime and homicide solvability increases, RECAP is prepared to expand to other cities in collaboration with National partnerships. It is our current commitment to collaborate with Federal, State, and local law enforcement and replicate violence reduction in additional cities. Host strategic plan convening, templates, training

manuals and workshops for engaging, educating, equipping, and empowering national leaders in Las Vegas NV. Our proven strategy and unique models for execution can easily be scaled without placing increased pressure for tax payer funding.

**MAYOR'S FAITH INITIATIVE. Pastor Martinez is a founding member of the City of Las Vegas Mayor's Faith Initiative (MFI).** The MFI further strengthens the community's ability to reduce violent crime and increase public safety. In 2012, over 120 faith leaders representing over 70,000 congregants from the Las Vegas Valley houses of worship responded to the Mayor's invitation to help change the city through Faith in Action. This was an expansion of the original Las Vegas Mayor's Community Interfaith Council founded in 2006 to build coalitions between entities such as faith-based organizations, police, courts, community organizations, specifically around critical public safety concerns;

- Create cultures of trust, with the goal of sharing information and resources within these coalitions; and
- Use proven principles and methods to combat and eventually neutralize the current culture of violence with a culture of peace and provide alternatives to promote healthy communities. It will also repair the relationships between inner-city communities and public safety stakeholders.

The Mayor's Faith Initiative utilizes the faith-based institutions that are embedded in neighborhoods as part of an emergency response plan regarding potential civil unrest or rioting, before and after an event. Pastor Martinez provides leadership and inspiration to harness passion into deliberate action and purposeful and pragmatic social services. The MFI was a finalist of the national **All-American City Award** in 2016. **The US Conference of Mayors** 2017 "City Livability Award" recipient was Las Vegas' Mayor's Faith Initiative recognized as both replicable and sustainable model to improve quality of life.

**SEX TRAFFICKING. Pastor Martinez is the Executive Director of the Nevada Sex Trafficking Awareness Campaign (NSTAC).** The statewide campaign launched in 2014. While directing the campaign Pastor Martinez was able to bring together a collaboration of the US Attorney of the District of Nevada, Nevada Attorney General, Clark County District Attorney, The Southern Nevada Human Trafficking Task Force which included the FBI, Local Police and Fire

Departments, Nonprofits and faith-based entities. The campaign kicked off with an award winning and Emmy nominated half hour documentary film produced by Pastor Martinez called “Trafficked No More”. Collaborating with NBC, CBS, ABC, PBS and Fox Television Stations to donate millions of dollars of air time to air simultaneously and uninterrupted to over 187, 000 viewing households.

**The US Department of State’s Office to Monitor and Combat Trafficking in Persons** vetted the “Trafficked No More” documentary high school version as well as student handbooks. The Clark County School District with over 300,000 students (5<sup>th</sup> largest in the Nation) utilizes the materials to provide a free “Trafficked No More” handbook to students after prevention class conducted by School Psychologists, Counselors and Health Teachers. Thousands of High School students receive these resources every year. The campaign continues to be successful to raise awareness of the issue of human sex trafficking by also conducting outreach and education in the community. This is sustained with no federal or state funding, only in-kind gifts, collaborations, private donation and millions of free airs time from the media. *The Clark County School District with 150,000 High School students utilizes the NSTAC as its sole resource to train 500 teachers and 18,000 students per semester.*

**Police Officers Standard Training (POST)** The State of Arizona utilized portions of the “Trafficked No More” materials in the Police Officers Standard Training (POST) of 16,000 Peace Officers statewide. This preparation for the increase of sex trafficking around Super Bowl XLIX in Phoenix in February, 2015 played a role in the identification and rescue of 23 minors being trafficked.

**COALITION BUILDING. Pastor Martinez has worked with the Governor’s Office of the State of Nevada and Nevada’s First Lady.** In 2007 a Coalition led by pastor Martinez began working to create a drug prevention model to reduce methamphetamine use in the Nevada. The Las Vegas Crystal Darkness Campaign reduced high school students trying meth by 50% by 2008. Pastor Martinez received the **Governor’s Points of Light Award** in 2008 for his leadership.

**DRUG PREVENTION STATEWIDE & REGIONAL EXPANSION DRUG PREVENTION** The Las Vegas Crystal Darkness Campaign model was replicated in California, Washington, Oregon, Oklahoma, Colorado, and New Mexico.

Every Major Television Network Statewide in Nevada aired the Documentary. Encore showing of the Documentary's air dates and times will be posted on the website.

Las Vegas has suffered greatly with 22,000 people attending the 1 October tragedy in addition to all the first responders, police, fire, rescue and hospital personnel who were directly involved. The loss of 58 deceased and more than 800 injured has created a renewed emphasis on violence prevention and public safety.

All sectors of our community participation are vital to the 3 to 5-year plan that is being drafted. The data and feedback from the crowd sourcing will assure the public has a voice in their ability to heal and be involved in the process as the plan evolves based on survey responses

### **MASS SHOOTINGS FAITH BASED AND COMMUNITY RESPONSE AND TRAUMA RECOVERY**

BELIEVE AGAIN initiative founding members have effectively bridged the gap between government entities, law enforcement, educators, business owners and the faith-based community in the aftermath of manmade disasters similar to the way that the City of Las Vegas realized a significant reduction in crime and improved awareness of sex trafficking and drug prevention.



The BELIEVE AGAIN COMMUNITY COLLABORATION operates as a Coalition of like-minded leaders in the above-described occupations, whereby the combined resources, energies, expertise and spheres of influence are joined together to combat the social issues and challenges the quality of life for that community's residents. The Coalition is committed to using the templates developed through its past ten years of successfully reducing crime and increasing public safety in the City of Las Vegas.

The focus of this business plan is to identify its future target clients, explain its marketing strategy, and to establish internal procedures so it can engage, equip, and enable other leaders to emulate the same model in their cities.

**SUSTAIN PROGRAM TRAUMA RECOVERY Mental Health Social Issues, Post Traumatic Stress Disorders from Mass Shootings.** The SUSTAIN Trauma Recovery is in partnership with the American Association of Christian Counselors (AACC) is offering this training at no cost in order to help mobilize and train the body of Christ to facilitate, the trauma-based bible study group, Living Hope, in order to bring healing to those who have been traumatized by the October 1st tragedy. The specific details of the Sustain road-map to recovery and healing. Sustain is a plan that is working together with the local faith-based community of leaders, pastors, chaplains, churches local law enforcement, local media, licensed Christian counselors as well as local counseling centers.

We appreciate the collaborative teamwork of the American Association of Christian Counselors, Standing United, Believe AGAIN, Las Vegas and the City-Wide Unity Prayer gatherings of churches who are leading the way in bringing healing to Las Vegas. We truly believe Las Vegas is already serving as a national example of how the body of Christ can come together, unite with city officials, rise up and respond to tragedy with a message of hope and healing to the victims of trauma.

**CROWD SOURCING** can be utilized to provide the opportunity that is desperately needed to seek and unleash the human potential. It can help enable our ability to reach the inner creativity, talent and basic desire to release/exchange the thoughtful expression of ideas in an organized way that can lead to the tangible delivery and implementation of solutions to address the difficult challenges that are currently facing the city of Las Vegas Trauma recovery as well as a reference for other cities experiencing Mass Shootings.

The deployment of a crowdsourcing platform to compliment the Las Vegas initiative aimed to assist in the healing/restoration of both the individuals impacted and the residents of the city. Furthermore, a crowdsourcing engagement can also be utilized to enable a proactive measure to mitigate possible future gun violence. Crowdsourcing is a novel and viable approach to assist this initiative in the following ways:

1. Examine new ideas to prevent violence and create awareness of gun violence: Desired outcome would be for the public to be involved in restoration of the process by offering compelling suggestions that can be implemented as viable solutions.
2. Promote an outlet for the organized expression of feelings and ideas that can promote emotional well-being and reduce fear related to the mass shooting event.
3. Study how a city responds to a tragic event and document best practices for its recovery: Desired outcome would be to recognize the impact of gun violence on a city and utilize these findings and ideas to help aid in potential future events either in Las Vegas or throughout the country,

**COMMUNITY CATALYST & FAITH BASED LEADRESHIP** provide Coalition building, consulting and training for City Officials, Law Enforcement, Faith-Based Leaders, business owners and Nonprofits interested in emulating much of the success the Coalition's members accomplished over the past 10 years of work with the Mayor of Las Vegas' Faith Initiative.

### **REPLICABLE MODEL**

The majority of the 1,407 cities in the United States have populations that exceed 30,000, of which the majority are experiencing crime, gang and drug activity as well as many other social issues that negatively impact the quality of life for its community residents. The social issues these cities face is too big for one government, the law enforcement, the faith-based houses of worship, nor the business community can solve independently.

It is the Coalition's objective to train and equip leaders from these communities who desire to emulate the programs and procedures that have been employed by the faith-based community in Las Vegas; and to do so without placing additional demand for tax dollars.

The Coalition has established proven models, or templates, for working with the following types of leaders:

- Faith-based organizations - this template prescribes methods, terminology and practices than are aimed at solving the social ills within the community

- Government and Law Enforcement - this template outlines how to engage local public officials to gain their endorsement by working together to solve the social issues using the resources of the faith-based community, business owners and non-government nonprofits orgs.
- Local business owners - The Coalition educates, consults, and encourages local business owners on win-win methods of gleaning where business owners commit a portion of their profits as a means of giving back to the communities that patronize their businesses. The template provides identification of participating businesses to the community thus encouraging community residents to patronize BELIEVE AGAIN partners. Lastly, the business donations are fully tax deductible and in many cases the business owners will realize increased profits based upon the publicity received by associating with BELIEVE AGAIN.

The key to success is found in educating, engaging, and empowering these leaders to work together in one unified fashion where the sum of all the parts is greater than the whole. Such cooperation between vastly different fields of practice and expertise is mission-critical toward successfully impacting the community in a tangible way that is felt by all. By unifying the various leaders, the local Coalition can effectively minimize its dependence on government tax dollars while at the same time improving the quality of life for its residents and therefore improving profits for its for-profit partners.

### **Financial Considerations**

The organization must rely heavily upon collaborating with public and private donors, business, and foundation sponsorship as well as like-minded leaders to launch and sustain its first six months activities. After that, it is expected that the public-private donations, fees and sponsorship funds from the training programs, workshops and speaking engagements will sustain the Coalition's ongoing operational expenses. To coin a phrase used by the LVMPD Sheriff, the existing partnership operates as a "force multiplier," thereby multiplying the resources of all involved parties to produce more than each could independently.

**LOS ANGELES GANG INTERVENTION. Los Angeles California inner cities violence interruption and para church ministry.** Pastor Martinez is a native of Los Angeles and was instrumental in leading gang violence intervention in the mid 1980's thru the height of gang homicides in 1991. Partnerships with Churches and NGOs in many of the most violent neighborhoods were formed to reduce homicides in Compton, East and West LA, South Central LA and San Fernando Valley. In 1991 the City of Long Beach experienced a spike in violence between newly formed Asian gangs from the Southeast Asia refugee population and Black and Hispanic gangs. Pastor Martinez established a Church plant that outreached to the affected area and eventually was instrumental in a gang truce. The ministry is continuing to serve Long Beach to date.

**LOS ANGELES RIOTS 1992, POST RIOT RESPONSE.** The LA Riots brought a new era of tension between law enforcement and inner-city communities. While living through the riots and aftermath was a significant setback there were some lessons learned by community leaders. POST RIOT RESPONSE is a critical component to normalizing the community. The realization that an approach of urgent response to any future escalating tensions must be taken. Engaging directly on the streets in the most affected areas to mitigate the damage and trauma was the approach taken by Pastor Martinez and 47 area Teams in the greater Los Angeles area.

**COMMUNITY ENGAGEMENT / AT RISK YOUTH. Government Housing Projects, HUD Section 8 Voucher residents and violent crime in Los Angeles.** Pastor Martinez established an additional Church plant in the Los Angeles Harbor area in 1993 and remained serving there thru 1998. The church location was two blocks from the housing projects and many of the residents in the surrounding neighborhood received Section 8 Vouchers. There was an obvious connection to homicide, violent crime, drug addiction and distribution, prostitution, racial tension and gang activity and the housing projects. The church and para church ministry continue to date. The notable successes are the families that could escape the cycle of poverty and violence. 23 years later 46-year-old Tim a husband and father now makes \$50. Per hour working at a refinery. Tim was a former Crip gang member and drug dealer who never worked a day in his life until his life changed as he was mentored through the ministry. Another example is Ed who had his common-law wife with six children on welfare, section 8 housing, food stamps, WIC program and Medicaid. Ed was a gang leader in the Hispanic gang and was unwilling to marry and take responsibility of his family due to fear of the government benefits being cut. Through counseling with Pastor Martinez, he came to realize the cycle of poverty his family would be bound too. Ed has now been married for 20 years and is a leader in the church and has a high paying job. Ed's adult children work and have never been on any government aid, the cycle of poverty has been broken.

**Pastor Troy and wife Sandra have been married for 38 years.** Have four adult children and nine grandchildren. Senior and founding Pastor of the East Vegas Christian Center since 1998. Founder of the 10,000 Kids Non-Profit organization since 2005 [www.10000Kids.org](http://www.10000Kids.org) . Pastor Troy has made it his life's calling to serve in the inner cities of America. A common thread of the many works he has been involved in is that there is a severe humanitarian need to be met.

Pastor Troy can go into a challenging or violent situation troubleshoot- quickly access the needs on the ground then create momentum to move in a positive direction. Troy is gifted at assembling passionate people to commit to a common goal. The results are evident in lives being saved and communities transformed. The fact that the efforts are community driven

allows progress and quick results. Local politics or systematic challenges will not impede the task at hand.

Pastor Troy has a unique perspective he gained through life experience. Born in Los Angeles to a teenage mother who herself was raised in an orphanage. Troy did not meet his father until Troy was 50 years old. Poverty, Drugs, Crime, Gangs, and cycles of violence were a social norm in the home and life as a youth. The personal transformation he preserved is an incredible asset to others.

The efforts by the Las Vegas Faith and Community as a whole have many commonalities with other cities who face similar social challenges, public safety and quality of life issues. Our wide scope of experience may provide solutions that benefit families and entire communities.

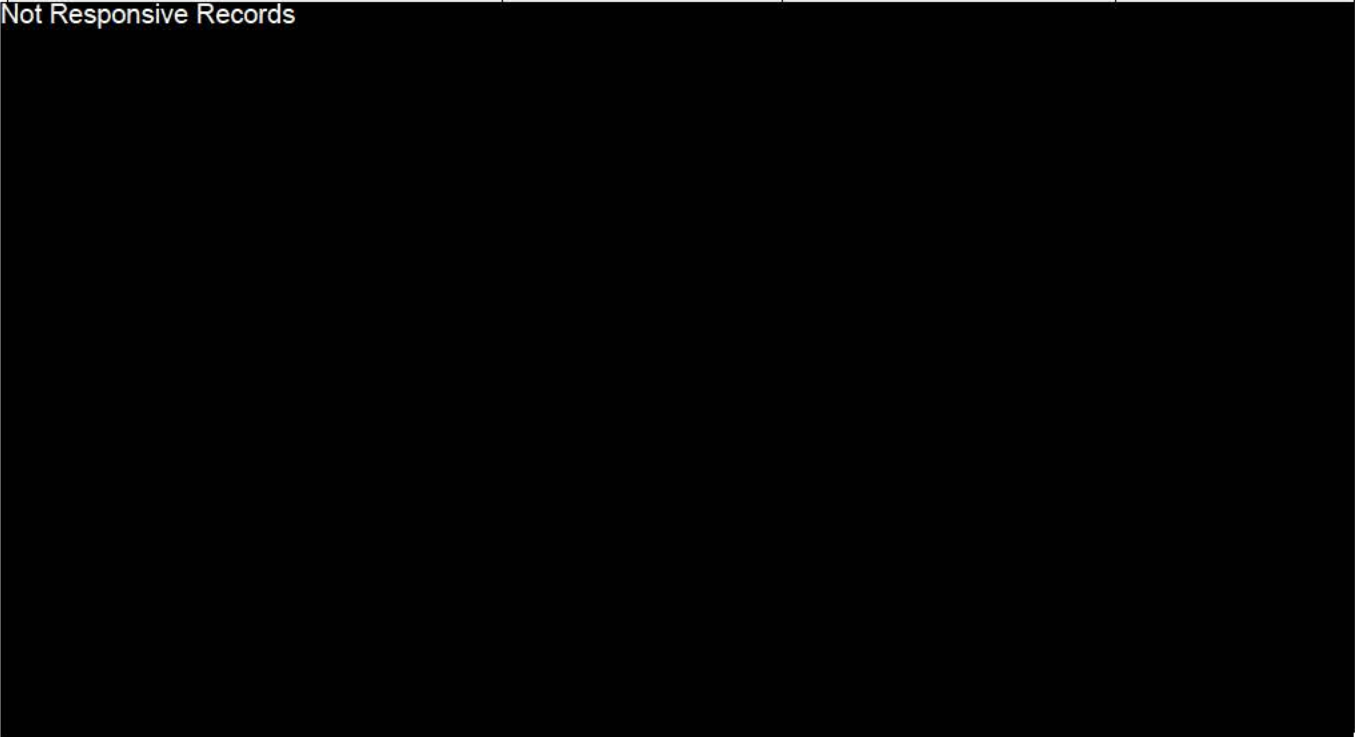

**Washington (CNN)**Attorney General Jeff Sessions on Monday announced [the Department of Justice's creation of a "religious liberty task force"](#) to "help the department fully implement our religious guidance."

In a [speech](#) at the Department of Justice's Religious Liberty Summit in Washington, Sessions said the goal of the task force will be protecting religious groups from persecution.

"The task force will help the department fully implement our religious liberty guidance by ensuring that all Justice Department components are upholding that guidance in the cases they bring and defend, the arguments they make in court, the policies and regulations they adopt and how we conduct our operations," Sessions said. "That includes making sure that our employees know their duties to accommodate people of faith."

Sessions cited "a dangerous movement" aimed toward stripping away the First Amendment right to freedom of religion as a basis for forming the new task force.

"A dangerous movement, undetected by many, is now challenging and eroding our great tradition of religious freedom," Sessions said in his speech. "There can be no doubt. This is no little matter. It must be confronted and defeated."

This is not the first time Sessions promoted the idea of federal protections for religious groups.

[Sessions issued a religious liberty memorandum](#) following [President Donald Trump's executive order](#) in May 2017, [which outlined how federal administrative agencies and executive departments should interpret federal law to protect religious groups](#).

In a memo released Monday morning, Sessions highlighted how the task force would implement the memorandum released last year.

"The Religious Liberty Task Force will continue the Department's ongoing work to implement the Religious Liberty Memorandum and the implementation memorandum," Sessions stated in the memo. "The Task Force will also consider new initiatives that will further the Department's work to protect and promote religious liberty." The task force will be co-chaired by Associate Attorney General Jesse Panuccio and Assistant Attorney General for the Office of Legal Policy Beth Williams.
