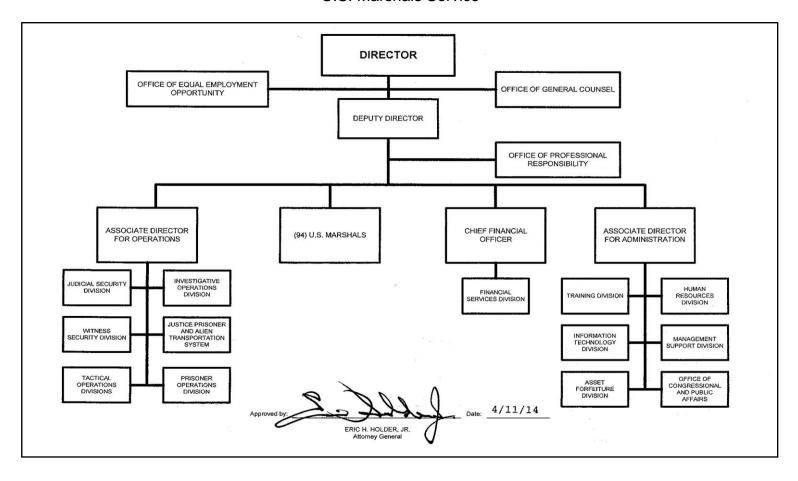
# **Organizational Chart**
