FY 2022 Budget Request At A Glance

FY 2021 Enacted: \$117.5 million (402 positions; 269 attorneys)

Current Services Adjustments: +\$3.0 million

Program Changes: +\$2.7 million

FY 2022 Budget Request: \$123.1 million (415 positions; 279 attorneys)

Change From FY 2021 Enacted: +\$5.6 million (+4.8%) (+13 positions; +10 attorneys)

Mission:

The National Security Division (NSD) works to protect this Nation's citizens against acts of terrorism and other threats to our national security through the rule of law. The NSD consolidates within a single Division the Department's primary national security elements outside of the Federal Bureau of Investigation. This organizational structure strengthens the effectiveness of the Department's national security efforts by ensuring greater coordination and unity of purpose between prosecutors, law enforcement agencies, intelligence attorneys, and the Intelligence Community (IC).

Organization:


The NSD is headed by an Assistant Attorney General (AAG), who is appointed by the President and confirmed by the Senate. The AAG oversees a Division that is organized into the Office of Intelligence (Operations, Oversight and Litigation Sections), the Counterterrorism Section, the Counterintelligence and Export Control Section, the Law and Policy Office, the Foreign Investment Review Section, the Office of Justice for Victims of Overseas Terrorism, and an Executive Office.


Resources:

The FY 2022 budget request for the NSD totals \$123.1 million, which is a 4.8 percent increase over the FY 2021 Enacted.

Personnel:

The NSD's direct authorized positions for FY 2022 total 415 positions, including an increase of 13 positions over the FY 2021 Enacted of 402 direct authorized positions.





FY 2022 Strategy:

In FY 2022, the NSD will continue to fulfill its responsibilities in the areas of Intelligence Operations, Oversight, and Litigation; Counterterrorism; Counterintelligence and Export Control; Cybersecurity; Foreign Investment Review; Law and Policy Advice; and Victims of Terrorism Outreach.

The NSD has outlined six areas of focus that will guide its operations. The NSD will:

- Prevent, disrupt, and defeat terrorist operations before they occur by integrating intelligence and law enforcement efforts to achieve a coordinated all-tools response to terrorist threats;
- Prosecute those involved in terrorist acts, adapting investigations to address changing terrorism threats, including domestic terrorism and cyber-enabled terrorism:
- Protect national assets from nation-state and terrorist threats, including through investigating, prosecuting, and disrupting espionage activity, proliferation, and foreign investment threat and strengthening partnerships with potential targets of intelligence intrusions;
- Combat national security cyber-based threats and attacks through the use of all available tools, strong public-private partnerships and by investigating and prosecuting cyber threat actors;
- Investigate and prosecute the unauthorized disclosure and improper handling of classified information; and
- Ensure that IC agencies have the legal tools necessary to conduct intelligence operations while safeguarding privacy and civil liberties.

The NSD's FY 2022 budget request maps to these goals and priorities and will ensure that the NSD remains best positioned to fulfill the Department's mission in the face of increasing challenges and a growing and evolving threat.

FY 2022 Program Changes:

Intelligence Collection and Oversight: \$2.7 million and 13 positions (10 attorneys)

This request will support extensive oversight and compliance work being handled by the NSD's Office of Intelligence, which is anticipated to increase in volume in FY 2022. This funding will also help the NSD provide oversight and compliance in FISA-related matters to prevent acts of terrorism, cyber-attacks, and to thwart hostile foreign intelligence activities. FY 2021 current services for this program are 138 positions (109 attorneys) and \$41.8 million.
