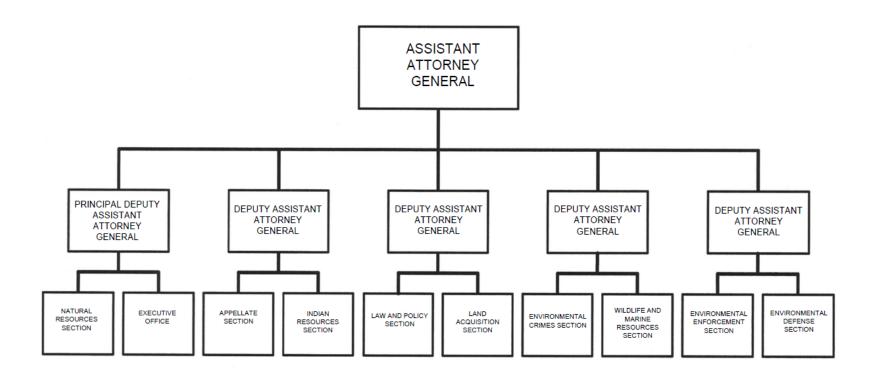

The amount requested, \$2,987,000, represents the pay amounts for 3/4 of the fiscal year plus appropriate benefits <u>Annualization of 2022 Approved Positions</u> Personnel: This provides for the annualization of new positions requested in 2022.  positions extends up to 2 years to provide entry level funding in the first year, with a 1 or 2-year progression to journeyman level. For 2022 increases, this request includes an increase of \$54,000 for full-year payroll costs associated with these additional positions. <u>Annualization of 2022 Pav Raise</u> This pay annualization represents first quarter amounts (October through December) of the 2022 pay increase of 2.7%.
