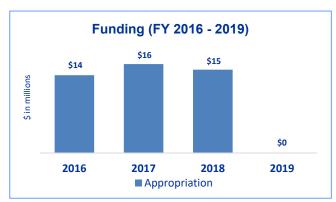
The FY 2019 budget proposes eliminating funding for CRS.

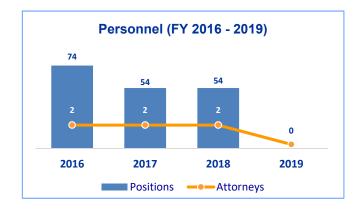
#### Personnel:

#### FY 2019 Strategy:

In FY 2019, to improve efficiency and reduce redundancies, the Service will be transferred to the Civil Rights Division, which has responsibility for enforcing all civil rights matters and for conferring with individuals and groups who call upon the Department of Justice in connection to civil rights matters.
